INDICTMENT

THE GRAND JURY CHARGES:

(Count One – Passport Fraud 18 U.S.C. § 1543)

1. Venue is proper in this district pursuant to 18 U.S.C. § 3238, the district of the last known residence of Defendant Faouzi Ayoub in the United States.

2. On or about October 8, 2000, said date being approximate, within the extraterritorial

jurisdiction of the United States, Defendant Faouzi Ayoub, also known as Frank Mariano Boschi,

wilfully and knowingly used and attempted to use a false, forged, or counterfeit United States

Passport, carrying the false passport number 196996130, in the false name of Frank Mariano Boschi,

in order to gain admittance into the State of Israel for the purpose of conducting a bombing on behalf

of the Designated Terrorist Organization Hizballah.

In violation of Section 1543 of Title 18, United States Code.
