RANA Iqbal... ISI was, he wanted, ISI to help me get

back to Pakistan.

SA PARSONS David wanted ISI to help you...

RANA Me...

SA PARSONS ... to get back to Pakistan?

RANA Right, so that if they gave me a forgiveness.

SA PARSONS Mmm-hmm

RANA If, I go back, they will have a court of inquiry

and all that.

SA PARSONS Okay.

RANA If I plead guilty, that I made a mistake they will

dismiss that and then they might say okay, get out

of here and you're fine. So, I'm not guilty.

SA PARSONS Mmm-hmm

RANA And I admitting that.

SA PARSONS Mmm-hmm

RANA And I want them to give me honorable discharge.

SA PARSONS Well, we respect that.

SA BENAVIDES (LAUGHS)

SA PARSONS Why was David helping you with ISI?

SA BENAVIDES (CLEARS THROAT)

SA PARSONS Why that introduction? What was going on then?

RANA The business that, you know, he used, is using his

personal, uh, things to get me a favor because,

you know, he is my friend.

SA PARSONS Okay.

RANA And he is, uh, helping the ISI and, uh, you know,

those people to work together or something.

SA PARSONS Right.

RANA Then he tells me, your question was, how what he

was talking to.

SA PARSONS Yeah, yeah.

RANA He said I talked about you.

SA PARSONS Okay.

RANA And then he, they made a call to me.

SA PARSONS Okay.

RANA And they said, uhm, doctor give me your PA number,

and give me the unit you went from.

SA PARSONS Okay.

RANA And when and uh, circumstances. I'm not sure if I

gave him because it's a major, uh, (UI)...

SA PARSONS That's fine.

RANA ...impossible...If I give, it would be a weak

point of my life, but I think I did not.

SA PARSONS All right.

RANA (UI)

SA PARSONS Well tell me more about what David did with ISI?

What other things did he tell you?

RANA Uh...the, he, according to him that this guy is

a, more of (UI). Balla talked to me about (UI).

He said ISI.

SA PARSONS Mmm-hmm

RANA Talking to me, helping certain politicians to set

up meat plants in Pakistan.

SA PARSONS Okay.

RANA Now, if he's a professional guy.

SA PARSONS Mmm-hmm

RANA He should be talking about something else.

SA PARSONS Mmm-hmm

RANA But he's talking to me, that I have a friend in

that city, and he wants to make a meat plant, a goat plant, and this and that. And I told them

I'm going to China.

SA PARSONS Mmm-hmm

RANA I'll go, uh, see the equipment because it's very

expensive here.

SA PARSONS Mmm-hmm

RANA And in China, once I buy goats, and then I'll come

back and I'm going to see Australia and New Zealand. Then I'll tell you what to do. Well they were uh, offering me, you know, even we are

not in...they were with, uh, Musharraf.

SA PARSONS Mmm-hmm

RANA That was after the Musharraf departed, they lost

that elections.

SA PARSONS Right.

RANA Say, it doesn't mean that your not in power at the

moment.

SA PARSONS Mmm-hmm

RANA (UI) if you're still okay, I mean, you can do me a

favor that's it. That's why I left Pakistan.

SA PARSONS Okay.

RANA That's the very reason, I have worked hard. I

want to stand on my own feet. I don't want any

favor. That's a sole problem I have with

Pakistan.

SA PARSONS (Laughs)

RANA If I've earned something, give me. If I don't,

don't give it to me. So then he become a little

and (UI), I didn't show him (UI).

SA PARSONS Okay.

RANA But Balla was talking business to me.

SA PARSONS Mmm-hmm

RANA While he is exempting ISI, and now when he says,

give me your PA number.

SA PARSONS Mmm-hmm

RANA It is more into the line of, you know,

professional.

PARSONS Right.

RANA ...uh...

SA PARSONS Well, We're more concerned about what David was

doing with ISI. So tell us more about what David

said your doing for, with ISI.

RANA I don't have a lot of details about which I can

recollect...

SA PARSONS Sure.

RANA ...but he does, uh, mention that I, uh, ISI

thinks I'm working for them and special things.

You know, I'm different and I'm much more into

this thing.

PARSONS Okay.

RANA Lashkar doesn't know, probably.

SA PARSONS Mmm-hmm

RANA That he's with, but ISI knows that he's with...

SA PARSONS Lashkar-E-Tayiba

RANA ...and that's what he was...
