STATEMENT OF PROBABLE CAUSE

Your complainant is an investigator with the St. Paul Police Department and he bases this complaint upon a review of reports and upon his own investigation. A short before a port of the bases in standing of the base of the

St. Paul Police report that on January 24, 2012 at approximately 2:00 p.m., they were dispatched to 715 Burr Street, St. Paul, Ramsey County, Minnesota, on a call of an assault in progress with a son having stabbed his mother and who was now trying to reenter the home by breaking a window with a shovel. Upon arrival police observed a man, later identified as SHARMARKE MOHAMED DUALE, D.O.B. 05/11/1991, on the front porch with a shovel in his hand. Police arrested Duale and then went inside and observed his mother, identified as S.H.W., with several defensive stab wounds on her hands. Police recovered a small folding knife that family members stated Sharmarke Duale used in the assault. M.H.D., the father of Sharmarke Duale, told police that Duale was trying to stab him with the knife and that S.H.W. tried to intervene and was cut.

Family stated that Sharmarke Duale had done well in school and college until he began attending a Mosque on University Avenue. Since that time he has been very disrespectful towards the women in the house and has threatened his father to try to get his father to assist Duale in getting a passport. Duale is raising money for Jihad and wants to go to Somalia. Sharmarke Duale threatened to hurt his father if his father did not get a passport for him stating, "Take me out of this country or I will show you what will happen, things will not be good for you." Sharmarke Duale then tried to stab his father with the knife, cutting his mother when she jumped in between them, then punching his sister in the head.

Sharmarke Duale's mother and father stated that they wanted him to get the help he needed and are afraid of him. Duale has been making threats towards his sister saying he was going to "chop them in pieces" and "kill the girls".

Police interviewed Sharmarke Duale at the Ramsey County LEC after arrest and Miranda. When questioned Duale denied having any mental health issues and denied using drugs. Duale stated that everything the family told police was all lies and that his mother had cut herself.
