1	THE COURT: Ladies and gentlemen of the jury, good
2	morning. We are ready to proceed.
3	Mr. Jonas?
4	MR. JONAS: Thank you, sir.
5	Q. (BY MR. JONAS) Good morning, Agent Burns.
6	A. Good morning.
7	Q. Before we move to the next subject matter, I just wanted
8	to briefly go over some of the questions and answers that we
9	had on Thursday just to clarify some things. Okay?
10	A. Okay.
11	Q. We discussed a document Elbarasse Search No. 8. Do you
12	recall that document?
13	A. I do. If you will give me one second. I have it.
14	Q. Okay.
15	MR. JONAS: If we can pull Elbarasse Search No. 8 on
16	the screen.
17	Q. (BY MR. JONAS) You had me at a disadvantage because I
18	don't have the exhibits with me. There are a lot of exhibits
19	we are going to go through today, so I didn't bother bringing
20	binders up like you have there.
21	In particular, this document discusses a trip taken by
22	the Defendant Shukri Baker to the West Bank and Gaza. Can you
23	tell us which page number that discussion is on.
24	A. That is on page 6, paragraph C.
25	Q. This discusses him going to the inside. And what is the

2	A.	Inside the Palestinian territories in Israel.
3	Q.	We also discussed a report of the trip which was marked
4	as I	InfoCom Search No. 51. Do you recall that document?
5	Α.	I do.
6	Q.	And we don't need to pull that one up. Who authored
7	Infc	oCom Search No. 51?
8	Α.	If you give me one second.
9	Q.	Sure.
10	Α.	This was a report from Shukri Abu Baker.
11	Q.	And does that reference the trip that was discussed in
12	Elba	arasse Search No. 8?
13	A.	It does.
14	Q.	And there is also another report of a trip that was
15	mark	xed or in evidence as Ashqar Search No. 2. Do you recall
16	that	document?
17	A.	I do.
18	Q.	Do you know who authored that document?
19	A.	I do not know who authored that document.
20	Q.	Does that document relate in any way to the report
21	auth	nored by the Defendant Shukri Baker in InfoCom Search
22	No.	51?
23	A.	Yes, it does.
24	Q.	How does it relate, based upon the exhibits you reviewed?
25	A.	This document, the one we are referring to now, which is
	1	

1	Ashqar Search No. 2, is a report of a trip in 1991 to the
2	Palestinian territories by someone based on the content, by
3	someone within the Palestinian Committee. They were reporting
4	on Hamas activities in the territories.
5	In that document, if you will turn to page 11
6	Q. Which exhibit is this? InfoCom Search No. 51?
7	A. Ashqar Search No. 2.
8	MR. JONAS: Ashqar Search No. 2, page 11.
9	THE WITNESS: Under Section K, the individual who
10	wrote this is reporting on activities in the Gaza area, which
11	is in the Palestinian territories.
12	Q. (BY MR. JONAS) And that is reflected in this document,
13	the Gaza Sector?
14	A. Yes. At the top you will see where it says the south
15	region and refers to the Gaza Sector. And throughout this it
16	refers to the Movement, which is Hamas.
17	And under Section K, at the bottom if you will look, it
18	says, "The brothers asked Dr. Al-Zahar to open a center for
19	studies and research, and he approved that." Doctor Al-Zahar,
20	as we identified last week, is Hamas leader Mahmoud Al-Zahar.
21	MR. JONAS: Your Honor, for the record I am going to
22	hold up Demonstrative No. 17.
23	Q. (BY MR. JONAS) And he is here on this chart here?
24	A. The closest to you.
25	Q. Where I am pointing?

L

1	A. Yes. So this document is reporting that the brothers met
2	with that individual to discuss opening a center for studies
3	and research. This document is based on a trip in 1991.
4	If you will turn back to Shukri Abu Baker's report from
5	1991 and turn to that exhibit number is InfoCom Search
6	No. 51. If you will turn to page 11 under "Gaza," Shukri Abu
7	Baker reported that he met with Mr. Abu Khalid, Abu Nasser,
8	and some other officials. They discussed with Mr. Abu Khalid
9	the subject of building a research organization. Abu Khalid
10	is the nickname for Hamas leader Mahmoud Zahar.
11	So the way I connected these two reports is that the
12	individual who wrote Ashqar No. 2, the Hamas report, the
13	Palestinian Committee member was actually reporting on Shukri
14	Abu Baker's meeting with Hamas leader Mahmoud Zahar.
15	Q. Okay. Agent Burns, if you recall, when you testified on
16	Thursday I showed you Hamas Charter No. 2, which is in
17	evidence, and that is the Arabic version of the Hamas charter.
18	Do you recall that?
19	A. I do.
20	Q. Okay. Who published that document?
21	A. The IAP.
22	Q. Did you find Where was that document found, if you
23	recall?
24	A. That one was found at the home of Ismail Elbarasse.
25	Q. Do you have before you Hamas Charter No. 1, which is not

1	in evidence?
2	A. I do not have the Hamas charters here.
3	MR. JONAS: Your Honor, one moment, please?
4	THE COURT: Yes.
5	Q. (BY MR. JONAS) I am referring to Hamas Charter No. 3.
6	MR. JONAS: And if I may approach, Your Honor?
7	THE COURT: Yes.
8	Q. (BY MR. JONAS) Where was that document found?
9	A. This document was found at the home of Ismail Elbarasse.
10	Q. And without going into the contents, what is it?
11	A. It is the English version of the Hamas charter.
12	MR. JONAS: Your Honor, at this time I would offer
13	into evidence Hamas Charter No. 3.
14	THE COURT: Any objections beyond what we have had?
15	That is admitted.
16	Q. (BY MR. JONAS) Agent Burns, you testified based upon the
17	Elbarasse search documents about a relationship between the
18	Holy Land Foundation the Islamic Association of Palestine.
19	Just to go back to that, what was the relationship between
20	those two organizations, from the Elbarasse search documents?
21	A. Based on all the exhibits that we reviewed last week,
22	they were members of the Palestine Committee whose job it was
23	to support Hamas, according to the 1992 memorandum from the
24	international Muslim Brotherhood.
25	MR. JONAS: And if we can quickly pull up Elbarasse

1	Search No. 10 on the screen.
2	Q. (BY MR. JONAS) Do you see the HLF and IAP on this chart?
3	A. I do.
4	Q. And does that support your statement about what you made
5	about the relationship between the HLF and the IAP?
6	A. It does. As we discussed on Thursday, the Central
7	Committee was the Palestine Committee.
8	Q. Have you reviewed the Baker deposition that we discussed
9	the other day?
10	A. Yes, I have.
11	Q. And in the Baker deposition does the Defendant Shukri
12	Baker discuss the relationship between the HLF and the IAP?
13	A. He is asked about it.
14	MR. JONAS: If we can put page 5 of that deposition
15	on the screen. If we can enlarge it.
16	Q. (BY MR. JONAS) Do you see where it says
17	MR. JONAS: One moment, Your Honor.
18	Q. (BY MR. JONAS) Agent Burns, do you have deposition page
19	64 and 65 in front of you?
20	A. I do.
21	Q. Okay.
22	MR. JONAS: We are trying to get it on the screen,
23	Your Honor. I think because it is a Monday morning the
24	computer is a little groggy.
25	And if you can enlarge the right hand column.

1	Q. (BY MR. JONAS) Can you read the question and the answer
2	regarding the relationship between the HLF and the IAP?
3	A. I can. The question that the lawyer asked is, "Now, you
4	understand"
5	Q. Agent Burns, let me provide you my copy.
б	A. I will read it off the screen. "Are you aware of any
7	relationship or affiliation of any sort between that entity
8	IAP and HLF?"
9	Shukri Abu Baker's answer is, "No affiliation. But what
10	do you mean by relationship? Can you itemize that?"
11	And the question, "Well, did you undertake any programs
12	together, work together in in any fashion?"
13	Answer: "We had a business relationship with the IAP."
14	Question: "Okay. Can you describe for me in general
15	terms the nature of that business relationship?"
16	Answer: "We advertised with their paper, and we used
17	their graphic design services. There were invoices for that,
18	and we had a contract to help us through their grass roots
19	volunteers, help the Foundation through its grass root and
20	volunteers to help dispense Holy Land Foundation literature
21	and fund raising material."
22	Question: "I've seen some indication that somewhere
23	that indicated that you were a member of an IAP advisory
24	board."
25	Answer: "Yes."

1	Question: "What was What was the advisory board?"
2	Answer: "You know, we would meet once a year, just
3	discuss overall issues, strategies."
4	Q. That is fine. Agent Burns, has Shukri Baker discussed
5	the HLF and IAP being part of the Palestine Committee in his
6	deposition?
7	A. No, he does snot.
8	Q. Was the Defendant Mohamed El Mezain also deposed in the
9	same lawsuit?
10	A. He was.
11	Q. And do you have his deposition before you?
12	A. I do.
13	Q. Okay.
14	MR. JONAS: Your Honor, at this time, subject to the
15	discussion prior, I would offer into evidence the Defendant
16	Mohamed El Mezain's deposition.
17	MR. DRATEL: Your Honor, based on what Mr. Jonas is
18	doing now, and subject to the other previous objections
19	THE COURT: Give me that exhibit number again.
20	MR. JONAS: The exhibit is Exhibit El Mezain
21	deposition is the title of the exhibit.
22	THE COURT: That is admitted.
23	Q. (BY MR. JONAS) Agent Burns, could you turn to page 25?
24	It is deposition page 25.
25	A. Okay.

1	MR. JONAS: I believe for purposes of putting it on
2	the screen, it is page 5. If you could enlarge the top left
3	hand corner.
4	Q. (BY MR. JONAS) Starting with the question on line 2.
5	THE COURT: Counsel, what are the dates of these
6	depositions? Has that been established?
7	Q. (BY MR. JONAS) For the record, the date of this
8	deposition is what, Agent Burns?
9	A. The date of this deposition is September 10th, 2003.
10	Q. And the date of the Baker deposition?
11	A. January 30th, 2003.
12	Q. Okay. If you can read this page, please.
13	A. It says Mohamed El Mezain's answer is, "You're right."
14	Question: "The MAYA conferences that you're referring
15	to, do you recall where those were held?"
16	Answer: "I Don't recall exactly what one of them."
17	Question: "Do you recall where whether any of them were
18	in Kansas City?"
19	Answer: "I don't recall."
20	Question: "The MAYA conferences where you met Mr. Ahmad
21	was either one of you a speaker at the conference?"
22	Answer: "No."
23	Question: "No? Have you had any personal dealings with
24	Mr. Ahmad outside of the MAYA conferences"
25	Answer: "No."

1	Question " you testified about."
2	Q. Let me interrupt you for a moment. Based upon Elbarasse
3	Search No. 10, is that the document that listed out the
4	members of the Palestine Committee?
5	A. Yes.
6	Q. Who is Mr. Ahmad?
7	A. Ahmed Yousef.
8	Q. Continue please. And is Ahmad Yousef one of the
9	individuals listed in the Palestine Committee document?
10	A. He is. You will see him referenced both as Ahmed Yousef
11	and Yousef Saleh.
12	Q. Is the Defendant Mohamed El Mezain also listed as a
13	members of the Palestine Committee on that document?
14	A. Yes, he is.
15	Q. Please continue reading.
16	A. Question: "Do you know a man by the name of Ismail
17	Elbarasse?"
18	Answer: "Yes."
19	Question: "How is it you know Mr. Elbarasse?"
20	Answer: "One of the MAYA conferences also."
21	Question: "Do you recall where that MAYA conference was
22	held?"
23	Answer: "I don't know. MAYA conferences, years, too
24	long."
25	Question: "Do you recall roughly what the time frame was

1	you met Mr. Elbarasse at a MAYA conference?"
2	Answer: "Is in the eighties."
3	Question: "How about Mr. Omar Ahmad? Can you tell me
4	the time frame?"
5	Answer: "It is in the eighties."
6	Question: "So you met both of these gentlemen at MAYA
7	conferences in the eighties?"
8	Answer: "Yeah."
9	And excuse me. I was referring to another part of the
10	deposition. When he said Mr. Ahmad, he was referring to Mr.
11	Omar Amhad not Ahmed Yousef.
12	Q. Who is Omar Ahmad?
13	A. He was a member of the IAP, also a member of the
14	Palestine Committee.
15	Q. Is he on the same list of the Defendant El Mezain in
16	Elbarasse Search No. 10?
17	A. Yes, he.
18	Q. Agent Burns, was the Defendant Mohamed El Mezain
19	questioned about the relationship between the HLF and the IAP
20	in his deposition?
21	A. Yes, he was.
22	Q. If you can turn to deposition page 87.
23	MR. JONAS: Which I believe is page 8 for the
24	purposes of pulling it up on the screen. No, I was wrong.
25	Take that down.

1	Q. (BY MR. JONAS) Agent Burns, just read on deposition page
2	87 line 15 where the Defendant El Mezain discusses a
3	relationship between the HLF and IAP.
4	A. Give me one second to see where it begins.
5	Q. Line 15 on page 87.
6	A. Okay. The question is, "Do you know of any relationship
7	or dealings that any of you principals of the Holy Land
8	Foundation had with the Islamic Association For Palestine in
9	January of 1989 that would have caused IAP to know about the
10	Occupied Land Fund and what it was doing?"
11	Answer: "No. Actually we You asked me before about
12	the people of IAP, and I said to you we know these people but
13	we don't have any relation with them, and they know that we
14	have established Occupied Land Fund in that time. Not only
15	the IAP actually, it became like, let me see, a custom with
16	the Muslim organizations to recommend a good organization for
17	the good cause."
18	Q. Again, Elbarasse Search No. 10, what does that document
19	indicate the relationship between the IAP and HLF is?
20	A. That they were both organizations within the Palestine
21	Committee working together.
22	MS. MORENO: Excuse me, Your Honor. I apologize for
23	interrupting. With respect to both the Baker deposition and
24	the El Mezain deposition, we would ask on behalf of Mr. Elashi
25	for a limiting instruction to the jury.

1	THE COURT: And we will come back to that later.
2	Go ahead.
3	Q. (BY MR. JONAS) Agent Burns, were there any Withdrawn.
4	In the Elbarasse search documents, do you recall there being
5	discussions about there being Palestine committees in other
6	countries?
7	A. I do.
8	Q. Was there one document that discussed any of the
9	Defendants traveling to another country in order to help
10	establish the Palestine Committee?
11	A. Yes. That Occupied Land Fund report we discussed
12	earlier.
13	Q. And what did that say, if you recall? If not, we can
14	pull the exhibit up on the screen. And we discussed that on
15	Thursday. Correct?
16	A. We did. And I have the exhibit here and I can tell you
17	what it says. It was Elbarasse Search No. 8. And under that
18	page 6 Do you
19	MR. JONAS: If we can put it on the screen.
20	Q. (BY MR. JONAS) Which exhibit is this?
21	A. Elbarasse Search No. 8, page 6. No. 8 at the bottom
22	under the Central Committee for charity work, it says,
23	"Brother Ghassan," which is the Defendant Ghassan Elashi, "is
24	currently on a visit to Britain representing the Fund in order
25	to study the possibility of forming a Central Committee for

1	charity work affiliated with the Apparatus in all the
2	countries with the goal of coordination, exchange of
3	experience, and finding the best ways to increase donations,
4	and to quickly respond to the request of the people inside."
5	MS. HOLLANDER: Excuse me. Your Honor, I am just
6	going to object to just repeating testimony here that the jury
7	already heard on Friday, and object to repeating the
8	testimony, exactly the same testimony.
9	THE COURT: Overrule the objection. He is
10	connecting it to a new exhibit. Go ahead.
11	Q. (BY MR. JONAS) Agent Burns, were there any phone
12	conversations involving the Defendants where they discussed
13	the Palestine Committee in another country?
14	A. Yes.
15	Q. Do you have before you HLF Wiretap No. 2? I know you
16	have several binders you need to look through.
17	A. If you will bear with me. I have it.
18	Q. Okay. Who are the participants on that call?
19	A. The Defendant Shukri Abu Baker, Akram Mishal.
20	Q. Who is Akram Mishal?
21	A. He was an HLF officer. And Ramsey Abu Baker.
22	Q. What is the date of the call?
23	A. June 25th, 2001.
24	MR. JONAS: Your Honor, at this time I would offer
25	into evidence HLF Wiretap No. 2.

9	A. I do.
10	Q. Who is that?
11	A. That is Akram Mishal, the HLF officer.
12	Q. And where it says "SH" underneath that, who is that?
13	A. That is Shukri Abu Baker.
14	Q. Okay.
15	A. The Defendant.
16	Q. I just want you to read this page and then some of the
17	next page, if you would, please?
18	A. Okay. Akram Mishal says, "Hello."
19	Shukri says, "Peace be upon you."
20	"Upon you be peace."
21	"How are you?"
22	"Praise be to God. What's new?"
23	"Good."
24	"This guy, a person named Mahmoud Ghazal called me from
25	Jeddah. Who is he?"

1	Akram Mishal says, "I believe he's from the Palestine
2	Committee."
3	"Hmm."
4	"When did he call you? Today?
5	"He left me a message today."
6	"Where? At home or"
7	"No, on the At the foundation."
8	Q. And the top of the next page.
9	A. "Strange. Its possible that he left it and someone
10	transferred it to you."
11	"Hmm."
12	"Yes, yes. Maybe I called him or I sent him a fax."
13	"Yes. They are from the Palestine Committee in the world
14	assembly."
15	"Yes, yes."
16	"Uh-huh."
17	"Okay. Call him and see what he wants. I wanted to"
18	Q. That is good enough. That is fine.
19	Agent Burns, I want to move away to another subject, and
20	I want to talk to you about the HLF money in the early years
21	of the Holy Land Foundation's life. Okay?
22	Do you recall some of the Elbarasse documents talked
23	about how much Holy Land Foundation raised in those early
24	years and sent over to the West Bank and Gaza?
25	A. Yes.

1	Q. Did you review any records that talk about how much money
2	was sent over to those areas?
3	A. I did.
4	Q. And I don't want to be that specific. I am just talking
5	about any money that they sent out from their bank accounts at
6	all.
7	A. Yes. I reviewed their bank account records from the bank
8	account they held at NAIT.
9	Q. Did you review other records as well?
10	A. I did. I reviewed search warrant material, things like
11	that.
12	Q. Generally, without getting into the description of
13	specific items, can you just summarize what you reviewed, what
14	it revealed?
15	A. Are you talking about a specific year or
16	Q. 1988.
17	A. 1988. The financial documents from the bank accounts and
18	the search warrant material, actually from the bank account I
19	think pretty much solely, indicated that a majority of the
20	HLF's money during that year was distributed to Mousa Abu
21	Marzook, his associates, and other individuals and entities
22	that were part of the Palestine Committee.
23	Q. Did you create a chart that summarizes these
24	transactions?
25	A. I did.

1	Q. Do you have before you what has been marked as OLF 1988
2	Disbursements?
3	A. I do.
4	Q. Is this chart based upon documents currently in evidence?
5	A. Yes.
6	Q. Would this chart aid the jury in understanding your
7	testimony?
8	A. Yes, it will.
9	MR. JONAS: Your Honor, at this time I would offer
10	into evidence OLF 1988 Disbursements.
11	MS. HOLLANDER: We have no objection, assuming it is
12	accurate, Your Honor.
13	THE COURT: That is admitted.
14	MS. HOLLANDER: Actually I do have one objection
15	which is remoteness, 1988.
16	THE COURT: That is overruled.
17	MS. CADEDDU: Is this a demonstrative?
18	THE COURT: No, ma'am. They are offering it
19	MR. JONAS: As a 1006 summary chart.
20	THE COURT: OLF 1988 is admitted.
21	MR. JONAS: Can we put the first page on the screen,
22	please?
23	Q. (BY MR. JONAS) Agent Burns, before we get into the
24	substance of the transactions, I would like you just to
25	explain to us how this chart is constructed.

1	A. Okay. The chart is constructed hopefully to make it easy
2	to understand this mountain of bank records that we have.
3	The first column includes the date of the transaction.
4	The next column indicates the source, where the payment in
5	that transaction came from. In this chart in particular, all
6	of the payments came from the Holy Land Foundation when it was
7	known as the Occupied Land Fund.
8	Q. Let me interrupt you as you go along. It says underneath
9	the Occupied Land Fund "North America Islamic Trust." What is
10	that?
11	A. That is NAIT, the Muslim Brotherhood organization that we
12	spoke about last week, and that is the entity through which
13	the HLF held its initial bank account.
14	Q. Okay. Continue.
15	A. Under the next section which is entitled "Authorization,"
16	on this chart it merely indicates whether or not the
17	transaction was done with a wire transfer or a check or
18	whether there was an expense voucher, and if on a particular
19	transaction an individual was linked to the transaction. For
20	example, if the Defendant Shukri Abu Baker requested the
21	transfer, his name will appear in this column as well.
22	The next column is the amount of the transaction. The
23	following column is the destination. That is to whom the
24	payment was made. And finally, the last column is the column
25	for exhibit number, which tells you the exhibit number and

1	specific page that you can go to and look at to see the actual
2	item that represents what is noted on this chart.
3	Q. And in that particular column there is an I next to some
4	of the page numbers and an S. What does that mean?
5	A. I represents the item, whether it be a check or expense
6	voucher or something like that. S would indicate the actual
7	statement.
8	And on this I would need to note that NAIT was not a
9	traditional bank like we are used to seeing, so the records
10	from NAIT appear different. There are a lot of handwritten
11	records and the bank statements look different than what you
12	would expect to see from a Bank of America, for example.
13	Q. When you look under authorization, just looking at the
14	first one as an example where there is a check and the number,
15	what does that number represent? Do you see 702648?
16	A. That would be like the transaction number.
17	Q. Okay. Or the check number?
18	A. The check number.
19	Q. Underneath that it says EXP voucher. What does that
20	mean?
21	A. Expense voucher.
22	Q. Where do you get that from?
23	A. From the records themselves.
24	Q. Well, let's look at some of these transactions. We are
25	on the first one. We see its destination to MAYA. Have we

1	seen MAYA somewhere else in some of the documents already
2	admitted?
3	A. We have. It was referenced on some of the documents that
4	we looked at on Thursday indicating that it was part of the
5	Muslim Brotherhood's organizations. If you will recall, the
6	document that was in Arabic that had the last page attached to
7	it with the list in English of the "organizations of our
8	organizations the organizations of our friends," it was listed
9	there. It was also listed on that chart that we saw of the
10	Muslim Brotherhood's apparatuses, and Shukri Abu Baker's name
11	was affiliated with it.
12	Q. Okay. Getting back to the first document you referenced
13	that had the list of the Muslim Brotherhood organizations, to
14	be clear, is that Muslim Brotherhood organizations in the
15	United States?
16	A. That is correct.
17	Q. And on that same list was the HLF mentioned?
18	A. Yes, it was.
19	Q. Okay. The next transaction you see is a \$10,000 check to
20	Yousef Salah. Do you know who Yousef Saleh is?
21	A. Yes. He is one of the members of the Palestine Committee
22	who was a part of the United Association for Studies and
23	Research, the UASR.
24	MR. JONAS: If we can pull up what is in evidence
25	Secretary of State VA-1, please, page 2 of that document.

Enlarge the bottom half, please.	
Q. (BY MR. JONAS) What is this document again, Secretary of	Ε
State VA-1?	
A. These are the articles of incorporation for the United	
Association for Studies and Research.	
Q. And what is that organization again?	
A. That was the We call it the UASR. It was listed on	
several of those documents you saw on Thursday, and is part of	E
the Palestine Committee.	
Q. So what does this identify Yousef Salah's role with the	
UASR?	
A. On this part it lists him as a director.	
MR. JONAS: If we can turn to page 3, please.	
Q. (BY MR. JONAS) And we see that again his name as a	
director?	
A. That is correct.	
Q. Does this document also have Mousa Abu Marzook as an	
individual associated with the UASR?	
A. From the earlier papers, yes, it does.	
Q. We covered that last week. Correct?	
A. We did.	
MR. JONAS: If we can go back to the OLF 1988	
disbursements, please, page 1.	
Q. (BY MR. JONAS) Agent Burns, how many pages is this	
chart?

And what is that organization again? A. That was the We call it the UASR. It was listed on several of those documents you saw on Thursday, and is part of the Palestine Committee. Q. So what does this identify Yousef Salah's role with the UASR? A. On this part it lists him as a director. MR. JONAS: If we can turn to page 3, please. Q. (BY MR. JONAS) And we see that again his name as a director? A. That is correct. Q. Does this document also have Mousa Abu Marzook as an individual associated with the UASR? A. From the earlier papers, yes, it does. Q. We covered that last week. Correct? A. We did. MR. JONAS: If we can go back to the OLF 1988 disbursements, please, page 1.

19	Q. Who was Fawaz Mushtaha?
20	A. He was the Palestine Committee member whose yard the
21	videotapes were found in.
22	Q. Is he also in the band?
23	A. He is.
24	Q. Okay.
25	A. Or was.

1	Q. Going down on this Staying with the same page, do you
2	recognize any other members of the Palestine committee on the
3	document you already discussed?
4	A. On the disbursement schedule on page 1?
5	Q. Yes.
6	A. Yes. I think it is not on the screen yet.
7	MR. JONAS: Pull up 1988 OLF Disbursements.
8	THE WITNESS: The person listed after Fawaz Mushtaha
9	is Hamas leader Mousa Abu Marzook.
10	MR. JONAS: If we can turn to the second page of

13	an individual named Nadia Elashi?
14	A. Yes.
15	Q. And if we can Who is Nadia Elashi, if you know?
16	A. She is the wife of Hamas leader Mousa Abu Marzook and the
17	cousin of the Defendant Ghassan Elashi.
18	Q. Okay.
19	MR. JONAS: If we can turn to the third page,
20	please.
21	Q. (BY MR. JONAS) Do you see there is \$50,035 wire to a
22	company called K&A Overseas Trading?
23	A. Yes. There are a number of those transactions on this
24	page to K&A.
25	Q. Did you create a sort of sub chart to K&A Trading?

1	A. I did.
2	Q. We will get to that in just a moment.
3	Did you also create a summary chart for the 1989 OLF or
4	HLF Disbursements.
5	A. I did.
6	Q. And do you have that before you?
7	A. I do.
8	Q. What is that sub chart What is that chart based upon?
9	A. It is a summary of the HLF disbursements in the year
10	1989, its second year of operation.
11	Q. And do these come from the NAIT records as well, like the
12	prior chart?
13	A. Yes.

15	into evidence Government's exhibit OLF 1989 Disbursements.
16	THE COURT: Same objections?

8	account to Nadia Elashi for \$10,000 on January 23rd, 1989.
9	Q. During the course of your investigation, did you come
10	across anything indicating whether Nadia Elashi was a charity
11	or needy person?
12	A. No, I did not.
13	Q. Going back to the 1989 disbursements, please, do you see
14	there are payments made to the Islamic Center of Gaza?
15	A. Yes.
16	Q. Did you create a sub chart of those payments as well?
17	A. I did.
18	Q. How much money was paid out? If you go to the third
19	page.
20	A. In 1989, approximately \$956,705.
21	Q. Did you come across anything in the documents that
22	indicated how much HLF claimed to have made or taken in
23	donations in 1988 and '89?
24	A. I found some documents in English that indicated what
25	they said they made in those two years.

1	Q. Do you have HLF Search No. 7 before you?
2	A. I do.
3	Q. Okay. Does that document indicate how much was received
4	by the HLF in these early years?
5	A. Yes.
6	MR. JONAS: Your Honor, at this time I would offer
7	into evidence HLF Search No. 7.
8	THE COURT: That is admitted from this morning.
9	MR. JONAS: If we can put that on the screen,
10	please.
11	Q. (BY MR. JONAS) Does this indicate how much money the HLF
12	made in 1988?
13	MR. JONAS: If we can enlarge the middle half,

24	A. The stated income here is \$300.

3	indicates how much money they may have received in 1989?

5	Q. Do you have before you HLF Search No. 8?

20	Q. Agent Burns, does it have a date on the top right hand
21	side?
22	A. It does. April 1st, 1994.
23	Q. Do you know You are not an IRS agent. Right?
24	A. No, I am not.
25	Q. Do you know what the purpose of this form is?

1	A. No, I don't.
2	Q. Outside of seeing this document itself, have you studied
3	these forms?
4	A. I have not.
5	Q. Line 1 says "Gifts, grants, and contributions received."
6	How much do they indicate in this document that they received
7	in 1989?
8	A. \$210,275.
9	Q. Do you have Did Shukri Baker ever publicly say how
10	much they received in 1989?
11	A. Yes, he did.
12	Q. Okay. Do you have before you what is marked as Baker
13	Declaration?
14	A. I do.
15	Q. And without getting into details, what is Baker
16	Declaration?
17	A. This is a written sworn statement by Shukri Abu Baker to
18	a federal court.
19	Q. Part of a lawsuit?
20	A. It is.
21	MR. JONAS: Your Honor, at this time I would offer
22	into evidence Baker Declaration.
23	MS. HOLLANDER: Nothing beyond, Your Honor.
24	THE COURT: All right. That is admitted.
25	MR. JONAS: If we can put page 2 on the screen,

25	Q. Do you see On the top of 105, what does it say about

2	A. It says

4	A. I am sorry. I have too many binders. It says, "In order
5	to manage the Palestinian Brotherhood's daily activities,
6	however, Yassin established al-Mujamma' al-Islami (The Islamic
7	Center) in Gaza. He served as its secretary general until
8	1984. The Center eventually coordinated the activities of all
9	organizations administered by the local Brotherhood."
10	Q. Is the word in brotherhood in caps?
11	A. It is.
12	Q. Indicating it is an entity?
13	A. Yes.
14	Q. And let me just show you again Demonstrative No. 17. It
15	says Yassin. Who is Yassin?
16	A. The founder and former spiritual leader of Hamas; the one
17	in the middle on the top.
18	Q. Sheikh Ahmed Yassin?
19	A. That is correct.
20	Q. By the way, does this article identify any other member
21	of Hamas we just saw on the chart, Demonstrative No. 17? And
22	to make it easier for you, I will direct your attention to
23	page 106, the bottom half.
24	A. It does.
25	Q. And that particular paragraph

8	Q. (BY MR. JONAS) This is transaction dated September 21st,
9	1989 for \$100,000, not including the \$35 fee. Who authorized
10	this transaction?
11	A. If you will look at the bottom, it says "withdrawal
12	requested by brother Abu Ibrahim," which that is the nickname
13	for the Defendant Mohamed El Mezain.
14	MR. JONAS: If we can look HLF Bank Account No. 3,
15	please, page 7.
16	MS. HOLLANDER: Excuse me, counsel. Have these
17	documents been introduced?
18	MR. JONAS: Yes, they have. I just introduced some
19	of these just now.
20	Q. (BY MR. JONAS) Can you make out Is this also to the
21	Islamic Center?
22	A. It is. That is the name that I referred to earlier
23	al-Mujama'a al-Islami. That is the written Arabic that
24	translates into the Islamic Center or the Islamic Complex of
25	Gaza.

19	A. By looking at the underlying records, both search warrant
20	and bank records, to see who the ultimate recipient was.
21	Q. And you see under this column for the exhibit it says
22	InfoCom Search No. 20. So if someone went to those words
23	contained within InfoCom Search No. 20, would they be able to
24	ascertain out of that \$45,000 total wire \$8,000 was meant for
25	the Islamic Center of Gaza?

1	A. That is correct.
2	Q. Are we going to see transactions like this throughout the
3	charts that you will testify about?
4	A. Yes. In the mid to late '90s you will see a lot of
5	those.
б	Q. The transaction underneath that dated July 15th, 1994, is
7	a similar set-up, the \$21,000 and it says/ILS \$39,000?
8	A. Yes.
9	Q. What is the ILS?
10	A. It stands for Israel shekels as opposed to U.S. dollars.
11	Q. If we don't see ILS, then what denomination are all these
12	other denominations in?
13	A. U.S. dollars.
14	Q. Do you see the column right next where it says
15	"Destination payment to Ibrahim Al Yazouri, Director of
16	Islamic Council"? Why is that there and in bold?
17	A. That is the ultimate recipient of the money, and he was
18	the individual that we saw referenced along with Sheikh Ahmed
19	Yassin in HLF Search No. 108.
20	Q. How do you know he is the ultimate recipient?
21	A. Based on the records that are referenced in that exhibit
22	column.
23	Q. Would that be InfoCom Search No. 20, or one of the other
24	items?
25	A. That is correct.

1	Q. If you turn to the last page, page 3, do you see there
2	are two lines that say "Hamas designation SDT, 1/23/95, and
3	then Hamas designation FTO, 10/8/1997"?
4	A. I do.
5	Q. What does that mean?
б	A. On the financial schedules, and we have a number of them
7	that we will be discussing, they are done chronologically.
8	And on all the charts we tried to note the dates of the
9	designations of Hamas so that you could see which transactions
10	occurred prior to and subsequent to those designations.
11	Q. In this instance, then, did the Holy Land Foundation send
12	any money to the Islamic Center of Gaza after Hamas was
13	designated?
14	A. I don't know the answer to that. I know that I could not
15	link any money to the Islamic Center of Gaza.
16	Q. Based upon what you reviewed and what is in this chart?
17	A. Right. That is correct.
18	Q. There were no transactions post designation?
19	A. That is correct.
20	Q. Okay. The total amount sent is how much to the Islamic
21	Center of Gaza?
22	A. \$733,245, plus \$56,100 Israeli shekels.
23	Q. You didn't convert that to dollars to include in the
24	\$733,000 number?
25	A. It has not been converted because it was impossible to

1	get a completely accurate conversion rate for the specific
2	date of the transactions, so we just left it in Israeli
3	shekels.
4	Q. Agent Burns, if you recall, on I believe it is the 1988
5	or 1989 OLF Disbursement charts there were payments to an
6	individual or organization known as K&A Trading. Do you
7	recall that?
8	A. I do.
9	Q. Did you create a chart just reflecting on those
10	particular payments?
11	A. Yes.
12	Q. Do you have that chart before you?
13	A. That is one that I do not have.
14	MR. JONAS: Your Honor, if I may approach?
15	THE COURT: Yes.
16	THE WITNESS: Thank you.
17	Q. (BY MR. JONAS) Do you have that chart now?
18	A. I do.
19	Q. Okay. Is that chart based upon items already in
20	evidence?
21	A. It is.
22	Q. Would that chart aid the jury in understanding your
23	testimony?
24	A. It will.
25	MR. JONAS: Your Honor, at this time I would offer

into evidence the exhibit marked as Payments to K&A Trading.
THE COURT: And those are admitted. The reason I
say it is On your chart, you show two, K&A/Marzook and K&A
Trading.
MR. JONAS: Correct. The K&A/Marzook we are going
to get to in a moment. It is a separate chart.
THE COURT: So this is the other one?
MR. JONAS: Correct.
THE COURT: Okay. Trading, that is admitted.
MR. JONAS: If we can put that on the screen,
please.
Q. (BY MR. JONAS) Agent Burns, when is the first wire
transfer to K&A Overseas Trading?
A. September 1st, 1988.
Q. When is the last wire transfer?
A. October 27th, 1988.
Q. Basically a little under a two-month period?
A. That is correct.
Q. And in this two-month period, how much money did the HLF
send to K&A Trading?
A. \$250,175.
Q. Is it safe to assume that the \$175 were wire transfer
fees?
A. Yes.
Q. \$35 per wire?

Α. That is correct. 1 2 Do you see where it says --Q. 3 MR. JONAS: Let's just pull up NAIT page 150 that 4 reflects a transaction of September 15th, 1988. (BY MR. JONAS) Who authorized this transaction, 5 Q. according to this document on the screen? 6 7 Α. The Defendant Shukri Abu Baker. 8 MR. JONAS: If we can scroll up a little bit, 9 please? 10 (BY MR. JONAS) Where was the HLF sending the money to 0. for these transactions to K&A Trading? 11 12 Α. The Banque De Paris in Switzerland. 13 I assume that is a bank. Q. 14 I am assuming. I don't speak French. Α. 15 Neither do I. Did you, during the course of the Q. 16 investigation make a request, or did someone from the 17 Department of Justice make a request to Switzerland to obtain those bank records? 18 19 Α. Yes. 20 Do you have before you what is marked as K&A Trading 0. 21 Account? 22 Α. I do. 23 And are those -- Is that the account where this money Q. 24 from the HLF was sent to? 25 Α. It is.

1	MR. JONAS: Your Honor, at this time I would offer
2	into evidence K&A Trading Account.
3	THE COURT: Admitted.
4	Q. (BY MR. JONAS) Agent Burns, the fact it is called K&A
5	Trading Account, does that mean it is not a trading account;
6	it is a bank account? Just so we are clear for the record?
7	A. Are you talking about our exhibit name?
8	Q. Yes.
9	A. Yes, that is correct.
10	Q. There is only so much space you can fit
11	A. On the little exhibit stickers. That is right.
12	Q. Okay. Agent Burns, how do you know that this is the same
13	account that the money was sent to, that the HLF money was
14	sent to?
15	A. Because the account number in these records is the same
16	as the account number referenced in the NAIT records from the
17	HLF.
18	Q. Okay. So if we can center on the middle, on the middle
19	of this page, do you see where it says 110441?
20	A. I do.
21	Q. I am not going to make us jump back and forth between the
22	documents, but is that number referenced on the wire transfer
23	authorization we saw a moment ago from the NAIT records?
24	A. Yes.
25	Q. Okay. And that is how you match up the wire transfers to

1	this particular account?
2	A. That is correct.
3	Q. Okay. Is there anywhere in this document that indicates
4	who owns or operates K&A Overseas Trading?
5	A. Yes.
6	Q. Okay.
7	MR. JONAS: If we look to page 6 of this document,
8	please.
9	Q. (BY MR. JONAS) Do you have any idea what language that
10	is in?
11	A. It is not English.
12	Q. Okay. On the right hand side in the middle we see a
13	name.
14	A. If we go to the next page, it is actually in English.
15	Q. Okay. Is that a translation, the next page?
16	A. Yes, it is.
17	MR. JONAS: Go to page 7, please.
18	Q. (BY MR. JONAS) Okay. What name do you see over there
19	for this account holder?
20	A. Mr. Khairy H. Al-Agha, Jeddah, Saudi Arabia.
21	Q. Would it make sense that the K of K&A Trading, Khairy, A
22	for Al-Agha, K-A?
23	A. I presume.
24	Q. Did you come across anything in the evidence you
25	reviewed, including the documents we discussed, that identify

1	who Khairy Al-Agha is?
2	A. Yes.
3	MR. JONAS: If you will turn to Ashqar Search No. 1
4	is. It is a document already in evidence.
5	Q. (BY MR. JONAS) Do you have that before you?
6	A. I do.
7	Q. Thursday when we talked about Ashqar Search No. 1, what
8	did we focus on, what particular page?
9	A. We focused on page 4.
10	Q. Which was?
11	A. The important phone and fax numbers for the Palestine
12	Section in America.
13	Q. And we looked at some of those names that matched up with
14	the Palestine Committee names in the Elbarasse documents?
15	A. That is correct. We compared this to those lists.
16	MR. JONAS: Let's go to page 5?
17	Q. (BY MR. JONAS) And what is the title of page 5?
18	A. Again, this is a translation. It says, "Important phone
19	and fax numbers. Palestine Section outside America."
20	Q. Do you see Khairy Al-Agha's name there?
21	A. He is the first person listed.
22	Q. Do you see where it says Saudi Arabia? Did we see Saudi
23	Arabia anywhere on the bank records of his that we looked at?
24	A. In the bank records on page 7 it was noted that he was in
25	Jeddah, Saudi Arabia.

1	Q. Did you see his name anywhere else in any of the
2	documents we discussed?
3	A. Yes.
4	Q. Do you have Marzook's Phonebook before you?
5	A. I do.
6	MR. JONAS: If we can pull up Marzook Phonebook,
7	page 54, please.
8	Q. (BY MR. JONAS) Do you see Where do you see Khairy
9	Al-Agha's name on the page?
10	A. The third name on the list says Dr. Khairy.
11	Q. How do you know that is Khairy Al-Agha?
12	A. Because if you look at the telephone numbers referenced
13	to the side of his name, first 966 is the country code for
14	Saudi Arabia.
15	Q. Okay.
16	A. But both of those numbers are the same phone numbers
17	referenced in Ashqar Search No. 1.
18	Q. Okay. While we are talking about Khairy Al-Agha and
19	Marzook, did you come across anything indicating that those
20	two individuals had a relationship?
21	A. Yes.
22	Q. And what did you look at?
23	A. There were bank records taken from Ismail Elbarasse's
24	home indicating a financial relationship between Marzook and
25	Khairy Al-Agha.

1	Q. Did you create a chart reflecting that financial
2	relationship?
3	A. Yes.
4	Q. Is the chart in the same format as these other charts we
5	talked about?
6	A. It is.
7	Q. Do you have before you an exhibit marked
8	K.Agha/K&A/Marzook?
9	A. Yes.
10	Q. Is that the schedule you created to reflect transactions
11	between Marzook and Khairy Al-Agha?
12	A. Yes.
13	MR. JONAS: Your Honor, at this time I would offer
14	into evidence the schedule marked K.Agha/K&A/Marzook.
15	THE COURT: That is admitted.
16	Q. (BY MR. JONAS) Agent Burns, before I get into this one,
17	can you remind us again the time period that the HLF was
18	sending money to Khairy Al-Agha?
19	A. It was from mid to late 1988. I believe the last
20	transaction was in late October. October 27th, 1988 was the
21	last transaction.
22	Q. When is the first transaction of this chart for payments
23	to Khairy Al-Agha and Marzook?
24	A. From Khairy Al-Agha to Marzook the first transaction is
25	the second on the chart, which is February 8, 1989, about

1	three and a half months after the HLF sent its last
2	transaction to K&A Trading.
3	Q. Was there a transaction prior to that between these two
4	individuals?
5	A. Yes. Mousa Abu Marzook actually sent \$15,000 to Khairy
6	Al-Agha in 1988, and the remainder of the transactions on this
7	chart were going the other directionK&A was sending the
8	money back to Marzook.
9	Q. Okay. You mentioned that some of these documents you
10	looked at to support this chart came from the Elbarasse search
11	warrant?
12	A. Yes.
13	Q. Did you look at bank accounts as well?
14	A. I did.
15	Q. It says Elbarasse Search No. 36. Is that some of the
16	documents you are referring to?
17	A. Yes.
18	Q. And Elbarasse Search No. 39?
19	A. That is correct.
20	Q. Then it says Marzook Bank Account No. 4. What is that?
21	A. That is one of the bank accounts held by Mousa Abu
22	Marzook.
23	MR. JONAS: Your Honor, at this time I would offer
24	into evidence Elbarasse Search No. 36, Elbarasse Search No.
25	39, and Marzook Bank Account No. 4.

1	THE COURT: Those are admitted.
2	Q. (BY MR. JONAS) Agent Burns, how much money was moved
3	from Khairy Al-Agha to Mousa Abu Marzook?
4	A. I think it was approximately \$1.3 million. There is not
5	a total on here, but if you add them up, it is well over a
6	million.
7	Q. Just so we are clear are, on the chart the first
8	transaction is shaded. Why is it shaded?
9	A. On the very first transaction?
10	Q. Yes.
11	A. To indicate the money was going in the other direction.
12	Q. You mean the other direction from Marzook to Khairy
13	Al-Agha?
14	A. That is correct.
15	Q. Then you have money not shaded, and that reflects?
16	A. Money going from K&A Overseas Trading to Marzook.
17	Q. Agent Burns, in reviewing all the search warrant material
18	and everything you have seen in the course of this case, did
19	you come across any explanation as to why Holy Land Foundation
20	was sending \$250,000 to Khairy Al-Agha?
21	A. I have seen information indicating that they said they
22	only sent to charitable organizations, and I researched this
23	and Khairy Al-Agha K&A Trading is not a charitable
24	organization. So no, I did not find an explanation as to why
25	they were sending so much money to K&A Overseas Trading.

1	Q. Okay. Staying with Marzook, let's talk about him for a
2	minute, did you see anything indicating that Marzook himself
3	sent money to the three organizations that comprise the
4	Palestine Committee, the UASR, IAP, and HLF?
5	A. Yes, I did.
6	Q. Did you create a chart that would summarize those
7	transactions?
8	A. I did.
9	Q. Do you have those charts before you?
10	A. I believe I need you to hand me those.
11	MR. JONAS: Your Honor, may I have a moment, please?
12	THE COURT: Yes.
13	Q. (BY MR. JONAS) Do you have a chart reflecting payments
14	Marzook and UASR?
15	A. I do.
16	Q. And what are those payments based upon and that chart
17	based upon?
18	A. Marzook bank records, Elbarasse search warrant material.
19	Q. Okay. And what is the time frame of the transactions
20	between Marzook and UASR?
21	A. March 2nd, 1992 through November 30th, 1992.
22	MR. JONAS: Your Honor, at this time I would offer
23	into evidence Government's exhibit I believe it is labeled
24	Marzook/UASR on the exhibit sticker.
25	Q. (BY MR. JONAS) Is that correct, Agent Burns?

I

1 Α. Yes. 2 MR. DRATEL: As to time frame, Your Honor. 3 MR. JONAS: I believe she covered the time frame. 4 MR. DRATEL: No, no. I am saying it goes to the 5 time frame, that is the objection. MR. JONAS: I thought that was a question, asking 6 7 the time frame. 8 THE COURT: That is overruled, and that exhibit is -- That chart is admitted. 9 10 MR. JONAS: If we can put page of that chart on the screen. 11 12 Ο. (BY MR. JONAS) Agent Burns, this is based upon, again, 13 Elbarasse search records? 14 Α. In part, yes. 15 As well as bank records? Q. That is correct. 16 Α. 17 MR. JONAS: Your Honor, I apologize. I am not keeping track of documents as I am admitting them, so I may 18 19 offer documents that are already in evidence just to play it 20 safe. 21 THE COURT: Sure. 22 MR. JONAS: At this time I would offer into evidence 23 Marzook Bank Account No. 3, Elbarasse Search No. 38, Marzook 24 Bank Account No. 1. So Marzook Bank Accounts No. 1 and 3 --25 THE COURT:

2	THE COURT: And then Elbarasse Search No. 38.
3	MR. JONAS: Correct, yes, sir.
4	THE COURT: And those are admitted.
5	MR. JONAS: Thank you.
6	Q. (BY MR. JONAS) Agent Burns, how many pages is this
7	document?
8	A. Two.
9	Q. Two? What is the total amount of money Marzook sent to
10	the UASR?
11	A. \$286,272.49.
12	MR. JONAS: Can we pull up page 54 I am sorry.
13	Page 52 of the Marzook Bank Account No. 3, and see one of the
14	items that support this chart.
15	Q. (BY MR. JONAS) Is that That is from the That is a
16	statement. Right?
17	A. That is correct.
18	Q. And that is the statement, if you can look at the chart
19	does it reflect any of the payments between Marzook and UASR?
20	A. Yes, it does. The June 30th payment, if you will look at
21	the second line from the bottom, it says June 30th with a
22	check number and then the amount \$34,169.42.
23	Q. Okay. Did Marzook make payments to the IAP?
24	A. He did.
25	Q. I am sorry. Before you leave the UASR, what was the

1	total time period he was making payments to the UASR?
2	A. March through November of 1992.
3	Q. 1992?
4	A. That is correct.
5	Q. What items did you review to support that he made
6	payments to the IAP?
7	A. Elbarasse search warrant materials as well as Marzook
8	bank records.
9	Q. Did you create a summary schedule of these payments,
10	these transactions between Marzook and the IAP?
11	A. Yes.
12	Q. Do you have that before you?
13	A. I do.
14	Q. Okay. And is that labeled Marzook/IAP, the exhibit
15	sticker?
16	A. Yes, it is.
17	MR. JONAS: Your Honor, at this time I would offer
18	into evidence Government's Exhibit Marzook/IAP.
19	THE COURT: Okay. That is admitted
20	Q. (BY MR. JONAS) And for the record, what is the title of
21	the schedule on the top? Is it a little more expansive than
22	on the exhibit sticker itself?
23	A. It is.
24	Q. What does it say at the top?
25	A. "Payments from Marzook to the Islamic Association For

1 Palestine." 2 MR. JONAS: If we can put the first page of that 3 exhibit on the screen, please. 4 (BY MR. JONAS) And by the way, Agent Burns, with the Q. 5 last exhibit UASR and this current exhibit, were there any 6 payments going from the UASR or IAP to Marzook, or was it 7 purely a one way street from him to them? 8 I don't think that there were payments, but I can't say Α. for sure that there weren't, based on these records. 9 10 Based upon the records. That is what I am asking. 0. That is correct. 11 Α. 12 Because in the Khairy Al-Agha transaction you said there Q. 13 was one transaction that went in the opposite direction. 14 That is correct. Α. 15 From what you have seen, it is from Marzook to all these Q. 16 entities? 17 Α. Yes. 18 Agent Burns --Q. 19 Your Honor, at this time I would offer MR. JONAS: 20 into evidence Marzook Bank Account No. 2. THE COURT: That is admitted. 21 22 (BY MR. JONAS) Agent Burns, could you -- You see where 0. 23 it says authorization? 24 Α. I do. 25 There is a few times where it says Elbarasse's name. Why Q.

01
is that?
A. Because he was the individual identified as having
authorized the specific payment out of the Marzook bank
account.
Q. And what is the time period of these transactions;
starting when and ending when?
A. The transactions begin February 11th, 1985 and they end
August 1st, 1992.
Q. Okay. In the Elbarasse records that we looked at the
other day, does it indicate how long in existence the IAP
how long IAP existed for?
A. Yes. I believe it was the first document we actually
looked at from Ismail Elbarasse's home indicated that the IAP
was originally created by the Muslim Brotherhood in the early
'80s.
Q. So it predates the Palestine Committee?
A. Yes.
Q. And the HLF and UASR, do they predate the Palestine
Committee, from the records we have seen and discussed?
A. They were all Well, the HLF was created about the same
time. 1988 was when the Palestine Committee was formed, and
the same thing with the HLF. And the UASR, I am not sure of
the actual date, but it was around the same time.
Q. Okay. So the fact that Marzook is making payments to the
IAP as early as 1985, I believe you said was the first

1	transaction, is that consistent with the material we have
2	discussed?
3	A. Yes.
4	Q. And the fact he is making payments to UASR in 1992, is
5	that also consistent
6	A. Yes.
7	Q. In terms of the creation of the organizations.
8	How much money did Marzook pay in total to the IAP? If
9	you look at the bottom of page 5.
10	A. \$757,864.
11	Q. Do you see in the last transaction, last two
12	transactions, it says Richardson, Texas?
13	A. Yes.
14	Q. Did the IAP have a presence in Richardson?
15	A. Yes.
16	Q. And are you basing that on the bank records that are in
17	evidence?
18	A. And also I saw the office there.
19	Q. For purposes of this chart?
20	A. Yes.
21	Q. Okay. Did Marzook make payments to any of the
22	Defendants, including the HLF or these Defendants
23	individually?
24	A. He did.
25	Q. Did you create a summary chart reflecting those payments

1	as well?
2	A. Yes.
3	Q. And what is the name of the summary chart for the
4	purposes of the sticker, the exhibit sticker?
5	A. The exhibit sticker says Marzook/Defendants.
б	Q. Okay. The title is different. The title says "Payments
7	Between Marzook and the Defendants"?
8	A. That is correct.
9	Q. And what did you base this schedule on?
10	A. The NAIT bank records some of the Marzook bank accounts,
11	Elbarasse search warrant material.
12	Q. Okay.
13	MR. JONAS: Your Honor, at this time I would offer
14	into evidence Government's exhibit Marzook/Defendants.
15	MR. DRATEL: The only objection is as to time frame,
16	Your Honor.
17	THE COURT: Okay. That is overruled, and that chart
18	is admitted.
19	MR. JONAS: If we can put the first page on the
20	screen, please.
21	Your Honor, at this time I offer I don't believe I
22	have offered Elbarasse Search No. 37 into evidence yet. If I
23	have, I apologize. If I have not, I am offering it now.
24	THE COURT: No. 37 is admitted. That was one of the
25	ones we discussed from this morning. That is admitted.

1	Q. (BY MR. JONAS) Agent Burns, when is the first payment
2	from the Holy Land Foundation to Mousa Abu Marzook?
3	A. The HLF paid Marzook \$10,000 on April 26th, 1988.
4	Q. Do you see on the far right on the exhibits there is
5	several page numbers for the NAIT records?
6	A. Yes.
7	Q. One of them has the I and one of them has the S. Can you
8	explain why there is multiple page numbers for this exhibit
9	for this transaction?
10	A. Because there were several items that went into creating
11	this transaction from the bank records, if you want to take a
12	look at them.
13	Q. I didn't mean to interrupt.
14	But they all support that there is one transaction?
15	A. That is correct.
16	Q. Okay. The first part it says destination to Marzook and
17	then Nadia Elashi. Again, who is she?
18	A. The wife of Mousa Abu Marzook.
19	Q. She is getting two \$10,000 payments; one on June 24th,
20	1988, and then there is one on January 23rd, 1989. The
21	spelling of the name is different. Why is thatElashi?
22	A. As often with some of these Arabic names, as they are
23	translated into English they are phonetically translated, so
24	they can be spelled in many different ways. A-L-A-S-H-I is
25	pronounced the same way as E-L-A-S-H-I.

1	Q. Is it spelled differently on this particular chart
2	because that is how it is spelled in the records?
3	A. That is correct.
4	Q. If you look at the second transaction to Nadia Elashi,
5	again January 23rd, 1989, it says BR Shukri. What does that
6	mean?
7	A. Brother Shukri, referring to the Defendant Shukri Abu
8	Baker.
9	Q. How do you know? Were there any other Shukris that you
10	came across in connection to the HLF?
11	A. At this time Shukri Abu Baker was the only Shukri that
12	was affiliated with the HLF.
13	Q. If you go down further on the right hand side where it
14	says destination, you have source now April 1985 Mousa Abu
15	Marzook, and then destination Shukri Baker. Can you explain
16	why we have had a shift in this chart from destination and
17	payment?
18	A. Okay. The chart was created for all payments between
19	Marzook and the Defendants, so it is organized by who the
20	source and destination were. So the original transactions
21	show Occupied Land Fund transactions with Mousa Abu Marzook.
22	The next section are transactions between Mousa Abu Marzook
23	and the individual Defendant Shukri Abu Baker chronologically.
24	So the first transaction with Shukri Abu Baker was April 17th,
25	1985.

1	Q. Going back to the top transaction, April 25th, 1988, how
2	soon after was this transaction occurred after HLF was
3	created?
4	A. Very shortly. We first saw the HLF in operation in very
5	early '88.
б	Q. And in going through all the search warrant material, did
7	you come across any explanation as to why Holy Land Foundation
8	is sending a total of \$30,000 to Mousa Abu Marzook?
9	A. No.
10	MR. JONAS: Can we turn to the next page?
11	Q. (BY MR. JONAS) Was Marzook sending money to other
12	Defendants besides the Holy Land Foundation and Shukri Baker,
13	as we saw on the first page?
14	A. Yes.
15	Q. Who else was he sending money to?
16	A. To the Defendant Ghassan Elashi.
17	Q. What is the time period for those payments?
18	A. Both of those were in 1988.
19	Q. And any other Defendant?
20	A. The Defendant Mohamed El Mezain.
21	MR. JONAS: Turn to the next page, please.
22	MR. DRATEL: What was the time frame on that?
23	Q. (BY MR. JONAS) What was the payment to Mohamed El
24	Mezain, the first and the last?
25	A. From July of 1988 through December 26, 1990.

1	MR. JONAS: Your Honor, the payments to El Mezain
2	are also reflected in Elbarasse Search No. 40. I don't
3	believe I have offered that one yet, so I do at this time.
4	THE COURT: That is admitted.
5	Let's go ahead and take the morning break at this time.
6	Let's be in recess until 11:00.
7	(Whereupon, the jury left the courtroom.)
8	THE COURT: Be in recess until 11:00.
9	(Brief Recess.)
10	THE COURT: Mr. Jonas?
11	Q. (BY MR. JONAS) Agent Burns, before the break we were
12	talking about payments from Marzook and the Defendants, as
13	well as the organizations that comprise the Palestine
14	Committee. On those three charts, are total amounts listed?
15	A. On some of them they are; not on the chart between
16	Marzook and the Defendants.
17	Q. Is that multiple individuals that are receiving money?
18	A. That is correct.
19	Q. Did you have an opportunity to total up the amount that
20	Marzook paid to the Palestine Committee through the
21	organizations or the Defendants themselves?
22	A. We did a rough estimate.
23	Q. Roughly how much did he pay?
24	A. Over \$1.2 million.
25	Q. You testified that the money to UASR, a lot of it was in

1	1992. Is that correct?
2	A. That is correct.
3	Q. And how about between him and the HLF?
4	A. Between Marzook and the HLF?
5	Q. I shouldn't say him. Between Marzook and the HLF, what
6	time period was he sending money to the HLF?
7	A. 1992.
8	Q. Did you review anything that indicates how much money
9	Marzook himself received in 1992 in order to make these
10	payments?
11	A. Yes.
12	Q. All right. Before we do that, can you just tell us again
13	how much did he pay to the UASR in 1992?
14	A. To the UASR the total in 1992 was \$286,272.49.
15	Q. And how much did he pay to the Holy Land Foundation in
16	1992?
17	A. 1992, \$210,000.
18	Q. So we are talking approximately half a million dollars
19	that Marzook paid out to the UASR and HLF alone in 1992. Is
20	that correct?
21	A. That is correct.
22	Q. Okay. Did you review any documents that indicates how
23	much money he himself made in 1992 which would go to support
24	these payments?
25	A. Yes.

1	Q. Do you have before you what is marked as Marzook Tax	
2	Return No. 1 or Marzook Tax No. 1?	
3	A. I do.	
4	Q. What is that item?

15	THE COURT: Admitted.	
16	MR. JONAS: If we can put the first page on the	
17	screen, please. Or the second page. Sorry. If we can scroll	
18	down now to the middle.	
19	Q. (BY MR. JONAS) I am sorry. Just to confirm at the top	
20	it says Mousa Abu Marzook and Nadia Elashi?	
21	A. It does.	
22	Q. You said Nadia Elashi is his wife. Is that correct?	
23	A. That is correct.	
24	Q. Does this say how much in wages Marzook earned in 1992?	
25	A. It says under taxable interest income \$6,809, and then

2	Q.	I am sorry, Agent Burns. I don't mean to interrupt you,
3	but ł	how much did he make in salary? How much does this
4	docur	ment indicate he made in salary in 1992?
5	Α.	His adjusted gross income was \$51,585.
б	Q.	I don't think you understand my question. Line 7 says
7	wages	s. Correct?
8	Α.	Right.
9	Q.	Wages is salary?
10	Α.	I am sorry. Yes.
11	Q.	How much did he earn in salary in 1992?
12	Α.	Zero.
13	Q.	Okay. How much income did he earn from other sources in
14	19923	?
15	Α.	The interest income was \$6,809.
16	Q.	And then how much other income did he earn?
17	Α.	Business income was noted as \$48,557.
18	Q.	Without analyzing this whole return, is there anywhere on
19	the 1	return that indicates what the business income was?
20	Α.	Yes.
21	Q.	And what was it?
22	Α.	Mecca Investments, an investment he had in a real estate
23	compa	any.
24	Q.	Is there anywhere in the return to indicate Marzook was
25	wealt	thy?

1	A. No.
2	Q. In the course of your investigation did you come across
3	any evidence that Marzook was wealthy?
4	A. I came across bank records to indicate he dealt with a
5	lot of money, but I did not see a legitimate source for that
б	money.
7	Q. Okay. Do you know what Marzook was doing in 1992 in the
8	United States?
9	A. I believe he was still a student in Louisiana at that
10	time.
11	Q. So did you come across, in examining this tax return, any
12	justification or source for \$500,000 that Marzook paid out to
13	these two entities, UASR and HLF, just those two alone?
14	A. No.
15	Q. Did Marzook take a tax deduction for his payments he made
16	to the HLF?
17	A. He took a tax donation for a payment that he made to the
18	HLF, but not for the entire thing.
19	Q. You said he made a total of \$210,000 in payments to the
20	HLF in 1992. How many payments did that comprise?
21	A. Three.
22	Q. What was the breakdown?
23	A. \$10,000, and then \$100,000, and then about ten days later
24	another \$100,000.
25	Q. If we could turn to page 11 of his tax return, do you see

1	where it says Schedule A?	
2	A. I do.	
3	Q. Contributions by cash, check. I am assuming that is what	
4	it means?	
5	A. Yes.	
6	Q. How much does it say that he contributed to the Holy Land	
7	Foundation in 1992?	
8	A. \$25,000.	
9	Q. Did the Holy Land Foundation give him a receipt for this	
10	money?	
11	A. They did.	
12	MR. JONAS: If you can turn to page 11, please.	
13	THE WITNESS: I believe it is page 13.	
14	Q. (BY MR. JONAS) I am sorry. We were on page 11. And do	
15	you see a receipt there from the Holy Land Foundation?	
16	A. Yes.	
17	Q. How much is it for?	
18	A. \$25,000.	
19	Q. Based upon your review of the bank records and the	
20	Elbarasse material in creating that schedule of payments by	
21	Marzook to the Defendants, did you actually see checks or wire	
22	transfers totaling the \$210,000 he made in 1992?	
23	A. Yes.	
24	Q. Is this \$25,000 receipt accurate?	
25	A. No.	
1	Q.	Based upon what you looked at?

3	Q.	Okay. Did any of the Defendants talk publicly about
4	their	relationship with Marzook?
5	Α.	They did.
6	Q.	Was any of this public discussion in a phone call
7	inter	cepted by the FBI?
8	Α.	Yes.
9	Q.	Do you have before you what has been marked as Baker
10	Wiret	ap No. 2?
11	Α.	Bear with me while I find my other binder.
12	Q.	Sure.
13	Α.	I have it.
14	Q.	I am sorry. Before we do that, I skipped one question.
15	Did y	you come across any evidence indicating that Marzook acted
16	as ar	n intermediary in getting money to the HLF?
17	Α.	Yes.
18	Q.	Do you have before you what has been marked as InfoCom
19	Searc	ch No. 83?
20	Α.	I do.
21	Q.	Okay. Without getting into the details, what is this
22	docum	nent?
23	Α.	It is a piece of correspondence that relates to a
24	trans	action involving Mousa Abu Marzook and the HLF.
25	Q.	Who signed this letter?

1	A. The Defendant Shukri Abu Baker.
2	Q. Is it on any letterhead?
3	A. The Occupied Land Fund.
4	MR. JONAS: Your Honor, at this time I would offer
5	into evidence InfoCom Search No. 83.
6	THE COURT: Admitted.
7	Q. (BY MR. JONAS) What language is this letter in?
8	A. It was in Arabic.
9	MR. JONAS: If we can put page 2 on the screen,
10	please.
11	Q. (BY MR. JONAS) What is the date of the letter?
12	A. February 17th, 1991.
13	Q. Okay. Just read where it starts, "His eminence," and the
14	next line?
15	A. It is addressed to "His imminence, the honorable Sheik
16	Omar Ahmad Badahdah. May good keep him. In reply to your
17	notification which we received on February 3rd, I would like
18	to inform you that we have received from your end the sum of
19	\$66,000 through brother Mousa Abu Marzook. We thank you, and
20	may God bless you. Hoping for your continued support to the
21	Fund, and apologizing for the delay in sending this note."
22	Q. That is fine. Okay. Getting back to where I was a
23	moment ago, do you have Baker Wiretap No. 2 before you?
24	A. I do.
25	Q. Okay. And is that a phone call involving any of the

3	Q. Who?
4	A. The Defendant Shukri Abu Baker.
5	Q. What is the date of the call?
6	A. April 1st, 1996.

10	another party regarding his or HLF's relationship with
11	Marzook?
12	A. Yes. This is a call in English between Shukri Abu Baker
13	and a reporter, an American reporter named Gayle.
14	MR. JONAS: Your Honor, at this time I would offer
15	into evidence Baker Wiretap No. 2 and No. 2-A, the
16	accompanying audio.
17	THE COURT: Ms. Hollander?
18	MS. HOLLANDER: I am not sure. Is 2-A is first
19	clip? Do they go in order?
20	MR. JONAS: Your Honor, excuse me.
21	THE COURT: Sure.
22	Any objections, Ms. Hollander?
23	MS. HOLLANDER: I am not sure which clip this is,
24	because I have them all as one, and I may have some 106, but I
25	will know as soon as I see it.

1	THE COURT: All right. Baker Wiretap No. 2 and 2-A
2	are admitted.
3	Q. (BY MR. JONAS) Agent Burns, for purposes of this trial
4	is the whole call being admitted, the entire call?
5	A. No, it is not.
6	Q. And what did you do with the call?
7	A. A lot of these calls were fairly lengthy, so what we did
8	was redact and include only the portions that were relevant to
9	what we were wanting to show here today.
10	Q. That is similar to what you did with the videotapes?
11	A. That is correct.
12	Q. Did the FBI change the content of the call in any way?
13	A. No.
14	Q. For purposes of this call, then, I think Is this call
15	broken down into segments?
16	A. It is.
17	Q. I think for right now we only want to play the fourth
18	segment.
19	(Whereupon, Baker Wiretap 2, clip 4 was played in open
20	court, while questions were propounded.)
21	Q. (BY MR. JONAS) I am sorry. This is a woman named Gayle,
22	you said, is a reporter.
23	A. That is correct.
24	Q. She referred to Mr. Marzook's attorney. At the time of
25	this phone call, do you know what was going on with Marzook?

1	A. Yes. Marzook had been arrested at JFK Airport in 1995
2	and was currently, at the time of this call, detained and
3	fighting his extradition proceedings.
4	Q. Okay. Marzook's phonebook is in evidence. Correct?
5	A. That is correct.
6	Q. Did you go through it?
7	A. Yes.
8	Q. Is the Defendant Shukri Baker's name in Marzook's
9	phonebook?
10	A. It is.
11	Q. Any other Defendants' names in the phonebook?
12	A. Yes.
13	Q. Okay. Whose?
14	A. We went through it the other day and identified the
15	number for Mohamed El Mezain as well as Ghassan Elashi.
16	Q. Okay. Shukri Baker is telling this reporter that maybe
17	his phone number is in Marzook's phonebook in relation to the
18	\$210,000 three donations that Marzook gave to the HLF.
19	Correct?
20	A. Actually he said
21	MS. HOLLANDER: Your Honor, I object to the leading
22	and repeating testimony.
23	THE COURT: Okay. Do you want to rephrase?
24	MR. JONAS: Sure.
25	Q. (BY MR. JONAS) What was Shukri Baker referring to when

1	he talked to Gayle, the reporter, regarding his name in
2	Marzook's phonebook?
3	A. He was Well, she had asked him why his number would be
4	in Marzook's phonebook, and he said that he guessed that he
5	probably picked it up around the time of the convention.
б	MR. DRATEL: Objection, Your Honor. She is just
7	repeating the transcript.
8	MR. JONAS: It is a foundational matter.
9	THE COURT: Yes. Go ahead.
10	Q. (BY MR. JONAS) We looked at the chart before, the
11	payments between Marzook and the Defendants. Focus on the
12	bottom half, please. Do you see there is a payment from
13	Marzook to the Defendant Shukri Baker?
14	A. I do.
15	Q. In 1985?
16	A. I do.
17	Q. And there is another one in 1985?
18	A. Yes.
19	Q. Okay. How much earlier before Marzook gave \$210,000 to
20	the HLF were these payments to the Defendant Shukri Baker?
21	A. Almost seven years.
22	Q. And there are some more payments on the next page?
23	A. Yes.
24	Q. So seven years prior to Marzook making this donation, he
25	is giving money to Baker. Is that correct?

1	A. That is correct.
2	Q. Okay. Did Shukri Baker talk to any other Defendant
3	regarding the phone conversation we just played, the one with
4	Gayle, the reporter?
5	A. Yes.
б	Q. Who?
7	A. The Defendant Mohamed El Mezain.
8	Q. Okay. Do you have Was that phone conversation
9	intercepted by the FBI?
10	A. It was.
11	Q. Do you have before you what is marked as El Mezain
12	Wiretap No. 11?
13	A. Yes.
14	Q. And who is the participants on that call?
15	A. This is a call between the Defendants Mohamed El Mezain,
16	Shukri Abu Baker, and Haitham Maghawri.
17	Q. What is the date of the call?
18	A. April 3rd, 1996.
19	MR. JONAS: Your Honor, at this time I would offer
20	into evidence El Mezain Wiretap No. 11.
21	MR. DRATEL: Your Honor, beyond the previous
22	objections, but also we have a 106
23	MR. JONAS: For this one?
24	MR. DRATEL: Yes.
25	MS. HOLLANDER: We do, too. I don't know if it is

1 the same 106. 2 THE COURT: Are you offering 11-A as well? 3 Yes, sir. MR. JONAS: THE COURT: No. 11 and 11-A. Those are admitted, 4 and we will deal with the 106. 5 6 MS. HOLLANDER: I am sorry to interrupt. I was just 7 going to see if we had the same 106. 8 THE COURT: All right. Go ahead. Have you looked 9 at their 106? 10 MR. JONAS: I have not, sir. Your Honor, this is the first I am looking at this. 11 Ι 12 just need a moment to see if we can agree. 13 THE COURT: Sure. Go ahead. 14 MR. JONAS: Your Honor, we are going to object to 15 their 106 requests. Okay. Let me take a look at that. 16 THE COURT: 17 (The following was had outside the presence and hearing of the jury.) 18 19 This is where theirs ends, and it MS. HOLLANDER: 20 ends by saying "We don't give to individuals," and then they 21 explain who they do give to. He is talking about who they 22 give to and who they support. And then if you leave it there, 23 it is just not complete, and in fairness the jury ought to 24 hear the rest of it. 25 THE COURT: Okay. Go ahead.

3	Q.	(BY MR. JONAS) Agent Burns, who is SH?
4	Α.	That is the Defendant Shukri Abu Baker.
5	Q.	Who is MO?
6	Α.	That is the Defendant Mohamed El Mezain.
7	Q.	Okay. Agent Burns, who is Abu Omar?
8	Α.	That is the nickname for Mousa Abu Marzook.
9	Q.	His Abu name?
10	Α.	Yes.
11	Q.	His oldest son is named Omar?
12	Α.	Correct.
13	Q.	Agent Burns, you see it says SB 210?
14	Α.	I see that.
15	Q.	What is that? Do you know?
16	Α.	I think that is just an error on the screen. On the
17	actua	al transcript that is Shukri Abu Baker SH saying 210.
18	Q.	So that is just out of place?
19	Α.	That is correct.
20	Q.	Okay. Do you see where the Defendant Mohamed El Mezain
21	says	"In one lump sum"?
22	Α.	Yes.
23	Q.	Was the payment the \$210,000 by Marzook to the HLF in one
24	lump	sum?
25	A.	No.

1	Q. How many sums was it in?
2	A. Three sums, three transactions.
3	Q. Do you see where it said the Defendant Shukri Baker
4	said, "We have no relationship issue," and politics right
5	above it. Was there a relationship between the Defendants,
6	HLF, and Marzook at this time period and going back to 1988?
7	A. Yes. The documents that we have reviewed indicate
8	MR. DRATEL: Your Honor, I am going to object to the
9	time period going back, because this call is in 1996.
10	THE COURT: Overruled. Go ahead.
11	THE WITNESS: The documents that we reviewed,
12	primarily on Thursday, but a few today, were dated in the late
13	'80s up until that chart that we saw in 1991 where Mousa Abu
14	Marzook was the head of the Palestine Committee of which the
15	Holy Land Foundation and the Defendants Shukri Abu Baker and
16	Mohamed El Mezain were a part at that very time.
17	Q. (BY MR. JONAS) Agent Burns, did you review any evidence
18	indicating that in fact there was telephonic contact between
19	Marzook and the Defendants?
20	A. Yes.
21	Q. Are these phone calls that the FBI intercepted?
22	A. No. Primarily this information came from old telephone
23	bills that were seized during search warrants and also what we
24	call toll records, which are records from the phone company
25	that were obtained by the FBI back during the time that or

L

1	in, you know, the early to mid '90s.
2	Q. What time period do you have these phone records for?
3	A. Approximately 1989 to early 1993, I think.
4	Q. Is there a reason why you don't have records for a later
5	time period?
6	A. Well, we didn't have all the phone records, and I don't
7	have all the phone numbers that the Defendants possibly could
8	have used. So I am sure my records are incomplete, but I
9	based my research on what I had available to me.
10	Q. Did you create a chart which summarizes the phone calls
11	between the Defendants and Marzook?
12	A. Yes.
13	MR. JONAS: Your Honor, may I approach the witness?
14	THE COURT: Yes.
15	Q. (BY MR. JONAS) Is this the chart that you are referring
16	to?
17	A. Yes.
18	Q. Is this chart based upon the records you just testified
19	about?
20	A. That is correct.
21	MR. JONAS: Your Honor, at this time I would offer
22	into evidence what is marked as Marzook/Defendant Phone Calls.
23	MS. HOLLANDER: May we approach about this exhibit,
24	Your Honor?
25	THE COURT: All right.

(The following was had outside the hearing of the 1 2 jury.) MS. DUNCAN: Your Honor, this exhibit was originally 3 4 designated as a demonstrative exhibit by the Government, and 5 then we learned yesterday that they are intending to, and I 6 may be wrong about exactly when, but they are intending to 7 introduce it as a summary. These are not voluminous records. This is not the kind 8 of records that would come in substantive evidence under the 9 10 summary rule. They are a demonstrative. So we object to it coming in as substantive evidence and as anything other than a 11 12 demonstrative to illustrate the Agent's testimony. 13 MS. HOLLANDER: All they have are phone records. In 14 other words, they have records of phone calls placed from a 15 phone number to phone number, and I think this is misleading. 16 MS. CADEDDU: I also believe it is misleading, and I 17 have some concerns about others of the Government's summary and demonstrative exhibits because they talk about the 18 19 Defendants, or Defendants, and my client is not listed on any 20 of those. 21 MR. WESTFALL: May I add one thing? 22 THE COURT: One more. 23 MR. WESTFALL: I haven't heard a single thing that 24 happened here, but for my purposes, they keep saying Marzook 25 and the Defendants. My Defendant isn't in any of this, so I

1	want to just ask for a limiting instruction, but I know you
2	said we are going to take that I do not waive my ability to
3	get a limiting instruction before this jury, so how do you
4	want to handle that?
5	THE COURT: We just have to address that. I have
6	not seen that exhibit. Do you have the Defendants, the names
7	on there?
8	MR. JONAS: Yes, sir. The names are right there.
9	THE COURT: Okay. All right. Okay.
10	I think that does qualify as a summary. There are enough
11	calls that it can come in as a substantive chart 106. And
12	then I think it is self-explanatory. I understand the
13	concerns you and Mr. Westfall have, but on its face it names
14	the Defendants, and of course you are asking the witness that.
15	MR. JONAS: I will ask a clarifying question to make
16	sure that we are not talking about the Defendants Abdulqader
17	and Odeh.
18	MS. CADEDDU: I would like to object generally to
19	the Government's statements "Have you seen evidence of such
20	and such between this person and the Defendants." I mean,
21	that implies that it is between other of the Defendants and it
22	isn't.
23	THE COURT: I don't know that the jury is catching
24	all of that. The evidence that comes in will show who the
25	calls are between, so I think the jury can understand what is

1 going on. 2 MS. CADEDDU: I would just like -- If the Government is going to talk about the Defendants, I would like them to 3 4 perhaps say "some of the Defendants" instead of "the Defendants." 5 6 THE COURT: It is some of the Defendants. That 7 would probably be good. 8 MR. JONAS: Yes, sir. 9 THE COURT: Okay. 10 (The following was had in the presence and hearing of the jury.) 11 12 THE COURT: All right. This is a chart, then, 13 Marzook/Some of the Defendants Phone Calls? 14 MR. JONAS: Yes, sir. 15 THE COURT: That is admitted. 16 MR. JONAS: For the record, I would like to also 17 admit the documents that Agent Burns referred to to support this chart, HLF Search Warrant No. 9 and HLF Search Warrant 18 19 No. 10. 20 (BY MR. JONAS) And Agent Burns, are those phone records Ο. HLF Search Warrant No. 9 and 10? 21 22 Α. I am looking to make sure that is all of them, because I 23 don't have a copy of the summary chart. There were --24 I know there are additional phone records, but HLF Search Q. No. 9 and 10. 25

Α. That is correct. 1 2 MR. JONAS: Also Your Honor, I would like to introduce Bell Atlantic No. 1 and Bell Atlantic No. 2. 3 4 (BY MR. JONAS) Agent Burns, are those also phone Q. 5 records? 6 Α. Yes. 7 MR. JONAS: Also, Your Honor, South Central Bell. 8 (BY MR. JONAS) Agent Burns, are those phone records as Q. 9 well? 10 That is correct. Α. MR. JONAS: And lastly, Your Honor, is New Jersey 11 12 Bell. 13 (BY MR. JONAS) Agent Burns, are those phone records? Q. 14 Α. Yes. 15 THE COURT: Any objections to HLF Search No. 9 and 16 10, and then the Bell, South Central Bell and New Jersey phone 17 records? MR. DRATEL: Just time frame. 18 19 MR. WESTFALL: Your Honor, may I address Mr. Jonas? 20 THE COURT: Sure. 21 MR. WESTFALL: Thank you, Your Honor. 22 THE COURT: And any other objections? Those 23 exhibits are admitted. 24 (BY MR. JONAS) Agent Burns, just to be clear, there are Q. three Defendants listed here? 25

1	A. That is correct.
2	Q. On the right. Defendant Shukri Baker, Defendant Mohamed
3	El Mezain, and Defendant Ghassan Elashi. Correct?
4	A. That is correct.
5	Q. And when we have been discussing the relationship between
6	Marzook and some of the Defendants, does that include all five
7	Defendants in this case, or all six if you include the HLF?
8	A. I am sorry. Can you repeat that?
9	Q. Are there any Defendants that did not have this
10	relationship with Marzook that we have been discussing, both
11	monetarily in terms of financial transactions, and phone
12	calls?
13	A. Yes.
14	Q. Who?
15	A. The Defendants Mufid Abdulqader and Abdulrahman Odeh are
16	not included on either the financial chart or the phone chart
17	that we are discussing here.
18	Q. So the Defendants that had a relationship with Marzook
19	are Defendants Shukri Baker, Mohamed El Mezain, Ghassan
20	Elashi, as well as the Holy Land Foundation?
21	A. The Defendants that had a relationship that I could
22	establish.
23	Q. Can you walk us through this chart, Agent Burns?
24	A. Yes. Basically this chart just indicates phone calls
25	between Marzook and the Defendants that are listed there. The

numbers, the telephone numbers for Marzook that were analyzed
are listed below Marzook's name. There were five of them; two
in Ruston, Louisiana. The 318 area code indicates the
Louisiana numbers. And 703 are the phone numbers that he had
once he moved to northern Virginia.
And then the time periods and the number of calls are
listed with an arrow indicating in which direction the phone
calls were going. For example, if Marzook On the top line
Marzook called the Defendant Shukri Abu Baker between January
3rd, 1989 and January 22nd, 1990 25 times.
And then on the other side it shows for the Defendant
Shukri Abu Baker, the phone numbers that were analyzed to put
together this chart. So those were the phone numbers
belonging to Shukri Abu Baker that Marzook had telephonic
contact with.
Q. And how soon How much time period Withdrawn. I
wasn't phrasing that correctly. The donation or the money
that Marzook gave to the HLF was in 1992, you stated. How
soon before that was the first phone call between Marzook and
Shukri Abu Baker?
A. Several years. 1989, January of 1989, so.
Q. And to be clear, did the FBI, as far as you know,
intercept any of these phone calls?
A. No, they did not. There were no During the times of
the calls referenced on this chart, there were no wiretaps of

1	any	of	these	individuals.

2	Q. Did the FBI intercept any phone calls at a later time
3	between Marzook and any of the Defendants listed here?
4	A. There may have been one that I am thinking of, but not
5	anymore than that.
б	Q. Okay. And from your review of the evidence and from your
7	review of these records, does this mean that there were no
8	phone calls between Marzook and the Defendants after the last
9	date on this chart?
10	A. No. As I said, I based this chart on the information
11	that I had available to me. I could only base my research on
12	what I had available.
13	Q. Did you try to get phone records going back to 1993
14	forward?
15	A. By the time the criminal investigation was instituted in
16	2001, a lot of older records, they were no longer maintained
17	by the telephone companies. But in addition that, I also
18	didn't have a complete listing of everyone's phone numbers,
19	their cell phone numbers. Mousa Abu Marzook moved overseas in
20	the mid '90s, or was overseas quite a bit. I don't have his
21	numbers for over there.
22	Q. In the Defendant Shukri Baker's deposition that we have
23	been referring to, did he discuss his relationship with
24	Marzook?
25	A. He did.
l	

1	Q. If you can turn to Baker Deposition, page 74, if you have
2	it in front of you. I can hand you a copy, if you need.
3	A. I have it. I just have to find it.
4	MR. JONAS: If you can put it on the screen. I
5	believe it is page 6 of the actual document.
6	THE WITNESS: Okay.
7	Q. (BY MR. JONAS) One moment to get it up on the screen.
8	A. Excuse me, Mr. Jonas. To point out, I think that there
9	is an error on that chart. That is what I wanted to check.
10	The 317 area code is actually for Indiana, not California.
11	That should be Indiana, not California.
12	Q. Okay. Thank you.
13	MR. JONAS: Okay. If we can enlarge the top right
14	hand page. That is 74 and 75.
15	Q. (BY MR. JONAS) Agent Burns, could you read what Shukri
16	Baker said regarding his relationship with Marzook in this
17	sworn deposition?
18	A. Yes. The question was, "How about Mr. Abu Marzook? Do
19	you know who he is?"
20	And Shukri Abu Baker's answer is, "Yes."
21	Question: "Okay. Now, it's my understanding at some
22	point he made a contribution to the Holy Land Foundation. Is
23	that correct?"
24	Answer: "Yes."
25	Question: "Okay. And I want to ask you about that in a

1	minute. Let's put that aside for the moment. Other than that
2	contribution, are you aware of any relationship or involvement
3	that Mr. Abu Marzook had with the Holy Land Foundation?"
4	Answer: "No."
5	Q. Did the Defendant Mohamed El Mezain also talk about his
б	relationship with Mousa Abu Marzook in his deposition?
7	A. He did.
8	Q. Do you have the El Mezain Deposition before you?
9	A. I do.
10	Q. Do you have starting on page 57, line 15? And if you
11	don't have that, I can hand you my copy.
12	A. I do.
13	Q. Can you read from page 57, line 15, to page 59, line 10,
14	please.
15	A. Okay.
16	Question: "Now, have you actually met Abu Marzook?"
17	Mohamed El Mezain's answer is, "Yes."
18	Question: "On how many occasions? Many occasions? One
19	or two?"
20	Answer: "He was living in Fort Collins, Colorado."
21	Question: "When you were there?"
22	Answer: "Yeah."
23	Question: "Did you socialize with Abu Marzook when you
24	were in Fort Collins?"
25	Answer: "Sometimes we sit in the mosque together, with

1 the people of the mosque, basically." 2 Question: "Other than your dealings with Mr. Abu Marzook 3 in the mosque in Fort Collins, did you have any other personal 4 dealings with him?" 5 Answer: "No. You cannot say personal dealings. 6 Sometimes -- Sometimes he call, congratulate our festival or 7 something like that. We go eat after or something like that." 8 Ouestion: "Sometimes he called. When you say, 'our festival, ' are you talking about an HLF festival?" 9 10 Answer: "No. We as mosque" --Agent Burns, let me interrupt you. I believe in 11 0. 12 discussion with Defense counsel, that is not supposed to be 13 That is supposed to be Muslims. But please continue. mosque. "We as Muslims have two festivals like the Christmas." 14 Α. 15 "Right. Like Ramadan?" Question: 16 Answer: "After Ramadan." 17 Question: "Okay." Answer: "This is before he left the country." 18 19 Question: "Okay." Answer: "After that, nothing more." 20 Question: "When you say, 'He called us,' I guess I was 21 22 confused. Who is 'us?'" Answer: "He called me." 23 24 Question: "He called you?" 25 Answer: "Maybe once a year or something like that, or

1	sometimes two, three years. It depends upon his call
2	sometimes. But we don't have any relation, direct relation".
3	Q. Agent Burns, let me interrupt you for a moment. How many
4	calls did Marzook make to El Mezain in the less than four-year
5	period that is reflected on your chart?
6	A. Fifty-two times.
7	Q. And if he was calling him two or three times a year, per
8	this deposition, during this time period alone, how many calls
9	would there have been?
10	A. He actually says one a year or once every two or three
11	years, so there would have only been a handful.
12	Q. Okay. Please continue.
13	A. Question: "Okay. And these phone calls were around the
14	time of the festivals, the holiday?"
15	Answer: "Yes."
16	Question: "Other than what you've described in terms of
17	these phone calls Mr. Abu Marzook would make around the time
18	of the festivals, your having sat with him in the mosque in
19	Fort Collins, and the distant family relationship, do you have
20	any other relationship with Mr. Abu Marzook over the course of
21	the years?"
22	Answer: "No. Sometimes I saw him in the conferences."
23	Q. That is good enough. Thank you, Agent Burns.
24	Did you look to see if there was a correlation on the
25	dates of the phone calls with any events going on at the Holy

L

1	Land Foundation?
2	A. I did find a correlation with some of the calls.
3	Q. And before I ask you that, I want to make sure that when
4	you have a time range here for calls, and just using as an
5	example the first one January 3rd, '89 to January 22nd, 1990
6	with the phone calls to the Defendant Shukri Abu Baker, do you
7	have the actual dates of those calls per the phone records?
8	A. Yes. You can actually go to the phone records and look
9	for the telephone numbers referenced and see the actual call,
10	the date, the length of time, et cetera.
11	Q. Okay. And in doing that, did you find a correlation
12	between certain calls and certain events with the Holy Land
13	Foundation?
14	A. Yes.
15	Q. What was your correlation?
16	A. On a couple of occasions I found that phone calls between
17	the parties happened at the time of HLF board meetings.
18	Q. Okay. Did you find that on more than one time?
19	A. I did.
20	Q. Okay. Agent Burns, I want to turn back to where we were
21	earlier this morning, the Occupied Land Fund Disbursements
22	1989 chart. Do you recall that?
23	A. I do.
24	MR. JONAS: If we can just pull that up real quick.
25	I am being instructed I need to put it on the elmo, and I

1	won't do that because I am moving on to another question.
2	Q. (BY MR. JONAS) In that 1989 disbursement chart do you
3	recall seeing payments made to an organization known as the
4	Islamic Relief Association?
5	A. Yes.
6	Q. Is that the right title Islamic Relief Association?
7	A. On the chart it says Islamic Relief. It is actually the
8	Islamic Relief Committee or Association. The word translates
9	to both.
10	Q. Okay. Did you create a sub-chart reflecting payments
11	between the HLF and the Islamic Relief Association?
12	A. Yes.
13	Q. Okay. Do you have that chart before you?
14	A. I don't think I have the chart.
15	Q. Okay.
16	MR. JONAS: Just give me one moment, sir. May I
17	approach?
18	THE COURT: Yes.
19	Q. (BY MR. JONAS) Now do you have the chart?
20	A. I do.
21	Q. Okay. And what is that chart based on?
22	A. This chart is based on search warrant material and also
23	HLF bank records and some Islamic Relief Committee account
24	records.
25	Q. Okay.

10	MR. JONAS: Your Honor, at this time as supporting
11	documents I would offer into evidence Government's Exhibit HLF
12	Search No. 44.
13	THE COURT: Admitted.
14	Q. (BY MR. JONAS) Agent Burns, let's just look at the last
15	transaction, the \$40,000 transaction, February 1996.
16	A. Uh-huh.
17	MR. JONAS: If we can put HLF Bank Account No. 1,
18	page 732 on the screen.
19	Q. (BY MR. JONAS) Is HLF Bank Account No. 1 a large
20	exhibit?
21	A. Yes, it is.
22	Q. And what is this document?
23	A. This is the signature card for that bank account.
24	Q. This is page 1 actually. Right?
25	A. That is correct.

1	Q. And whose name do you see on this card?
2	A. The Defendants Ghassan Elashi and Shukri Abu Baker.
3	MR. JONAS: Can we get page 732, please, on the
4	screen?
5	Q. (BY MR. JONAS) Does this reflect this item reflect
6	the payment to Islamic Relief?
7	A. This is part of the statement. I believe you have to
8	scroll to some of the later pages to actually see the exact
9	transaction.
10	MR. JONAS: Let's go to next page, please.
11	Q. (BY MR. JONAS) Do you see it here?
12	A. Yes. The wire transfer was dated February 15th, 1996 in
13	the amount of \$40,000. So if you look on the statement
14	February 15th, you can scroll across and see wire transfer
15	\$40,000.
16	Q. How do you know that went to the Islamic Relief
17	Association?
18	A. I believe if we scroll forward we will see the exact
19	item. If not, then it is based on the search warrant records
20	that are also referenced in the exhibit column.
21	Q. So the item that is telling you where this money went is
22	contained either in the bank records or the search warrant
23	records.
24	A. They are referenced here, yes.
25	Q. And the schedule tells people where to go to find those

2	A. That is correct.
3	Q. We are not going to go through every single page. Okay?
4	A. Okay.
5	Q. Did you find the letter in Elbarasse's material regarding
6	a request for \$100,000?
7	A. Yes, I did.
8	Q. Do you have Elbarasse Search No. 17 before you?
9	A. I do.
10	Q. What is the date of that letter, if it is dated?
11	A. It is dated July 20th. Based on the content, we were
12	able to put it in 1992.
13	Q. Okay. Do you have the author of the letter, who signed
14	it?
15	A. It was signed in code.
16	Q. Is it addressed to anybody?
17	A. It is not.
18	MR. JONAS: Your Honor, at this time I would offer
19	into evidence Government's Exhibit Elbarasse Search No. 17.
20	MS. MORENO: Subject to our previous objections,
21	Your Honor.
22	THE COURT: All right. That is admitted.
23	Q. (BY MR. JONAS) Agent Burns, do you have in front of you
24	InfoCom Search No. 3 as well?
25	A. I do.

What is that item? 1 Q. 2 This is a project summary report for an HLF project with Α. the Islamic Relief Committee. 3 Agent Burns, am I going somewhere with these random 4 Q. 5 questions? 6 Α. 11	Demonstrative No. 8?
12	A. I do not have the demonstrative.
13	MR. JONAS: May I have a moment, please?
14	THE COURT: Yes.
15	MR. JONAS: Your Honor, we don't have a copy up
16	here. I think we left ours downstairs.
17	Q. (BY MR. JONAS) Agent Burns, do you know what I am
18	referring to when I refer to Demonstrative No. 8?
19	A. I do.
20	Q. Did you create Demonstrative No. 8?
21	A. Yes.
22	Q. And is it based upon the documents that are currently in
23	evidence?
24	A. That is correct.
25	MR. JONAS: Your Honor, at this time I would offer

3	Q. Have you seen that in some of the documents we have
4	discussed?
5	A. Yes.
6	Q. The Hamas charter?
7	A. Yes.
8	Q. Please go on.
9	A. Actually I don't believe it was in the Hamas charter,
10	but, I mean, it has been in several of the documents that we
11	have referenced.
12	Q. Okay.
13	A. "In response to the martyrdom of the military leader of
14	Ezz Eddin al-Qassam Brigades, the military wing of the Islamic
15	Resistance Movement, Hamas, the Brigades carried out a violent
16	attack on a Zionist military patrol unit in the Jibalia region
17	on Saturday July 18th. The attack led to the injury of a
18	number of the patrol unit members, and the heroes of the
19	Brigades returned safely to their bases.
20	"It is a jihad for the sake of God. A victory or a
21	martyrdom.
22	"We have bargains of very modern and different pieces of
23	steel in front of us, and they are being offered to us for
24	purchase now. Otherwise, they will be offered to Fatah.
25	Therefore we hope"

1	Q. Agent Burns, I am sorry. Have we seen Fatah in this
2	case?
3	A. Yes.
4	Q. What is Fatah?
5	A. It is basically the secular party in the Palestinian
6	territories, the party of Yasser Arafat.
7	Q. Please continue.
8	A. "Therefore we hope that you send \$100,000 very quickly to
9	conclude the bargains before they are sold, as the positive is
10	in dire need for them to replace the old pieces, all of which
11	are not worth one new piece.
12	"Send us the approved budget for the company for month 7.
13	"Salah the treasurer still refuses to give us the sum of
14	money. Contact him as our financial situation is difficult.
15	"Yesterday an agreement to solve Fatah's problem has been
16	reached, and if the assaults continue we will respond to Fatah
17	in the appropriate manner.
18	"May God bless you. July 20th."
19	Signed Seven Up.
20	Q. Were you ever able to determine who Seven Up is?
21	A. I don't know.
22	MR. JONAS: If we can go back to Demonstrative No. 8
23	now, please.
24	Q. (BY MR. JONAS) Please continue explaining this timeline.
25	A. On July 30th, telephone records referenced here indicate
l	

1	that Hamas leader Mousa Abu Marzook placed a phone call to the
2	Defendant Mohamed El Mezain.
3	Q. Let me ask you There are two pictures under that
4	reference. Who are they?
5	A. The one on top is Hamas leader Mousa Abu Marzook and the
6	one below is the Defendant Mohamed El Mezain.
7	Q. Please continue.
8	A. Two days later Mousa Abu Marzook issued a \$100,000 check
9	to the HLF.
10	Q. Is that reflected on the summary schedule we looked at
11	before of money moving from Marzook to the HLF?
12	A. It is. And the check is located in the bank account
13	referenced, the exhibit referenced here.
14	Q. Is that part of the \$210,000 that has been discussed?
15	A. Yes.
16	Q. Please continue.
17	A. Five days later the Holy Land Foundation approved a
18	project called Project 236 for \$100,000 for prisoners'
19	families through the Islamic Relief Committee. And the wire
20	in that case was requested by the Defendant Ghassan Elashi.
21	Q. Is that a picture of the Defendant there?
22	A. It is.
23	Q. Continue.
24	A. Then four days later the HLF actually wired \$100,000 to
25	the Islamic Relief Committee for that project.
1	Q. Did you look at InfoCom Search No. 3, the project binder,
----	---
2	which supported the \$100,000 payment?
3	A. Yes.
4	Q. And were you able to Based upon the documents
5	contained within that project binder, were you able to account
6	for the \$100,000 being used for anything?
7	A. The project was very confusing. The initial
8	documentation from the time
9	MR. DRATEL: I object that the project was
10	confusing, Your Honor.
11	THE COURT: Overruled. Go ahead.
12	THE WITNESS: The time of the initial project in
13	1992, the paperwork indicates that there was \$100,000 to go to
14	100 needy families. Attached to that were applications for
15	approximately 100 families with a suggested amount to be
16	issued to those families. Two years later
17	Q. (BY MR. JONAS) I am sorry. Before you go forward,
18	roughly how much was the suggested amounts?
19	A. The suggested amounts varied, but on average about \$200
20	per family.
21	Q. Did you figure out how much, based on those suggested
22	amounts, should have gone to those 100 families?
23	A. Much less than \$100,000. If you multiply on average \$200
24	for 100 families you have \$20,000.
25	But again, about two years later And if we could go to

L

1	that exhibit, I can show you what I am talking about.
2	Q. Sure. Which page number?
3	A. Okay. If you go to page It is a very large exhibit
4	because of the 100 families whose applications are attached.
5	Q. Are those 100 family applications, would that be
6	supporting documentation for the wire transfer?
7	A. Correct. As I said, the initial paperwork said this
8	\$100,000 was to go to 100 needy family, and then approximately
9	100 needy family applications were attached.
10	If you go to 336 of the exhibit, which is
11	Q. InfoCom Search No. 3?
12	A. Yes. This is the Arabic version of the document, and I
13	believe the translation is hopefully just after this. Yes.
14	Later, two years after the initial project, a final report was
15	filed along with this indicating that \$100,000 was issued to
16	500 families.
17	Q. Did you find supporting documentation for 500 families?
18	A. No. As I said, the paperwork included the initial 100
19	family applications.
20	Q. Did you look to see if the paperwork for the 400
21	additional families were anywhere in the search warrant
22	material?
23	A. I looked for Project 236, and I could not find any
24	additional families that went along with this project.
25	Q. Okay. Agent Burns, after this first initial \$100,000

1	transaction occurred, did you see something similar happen
2	shortly thereafter?
3	A. Yes, very shortly thereafter.
4	Q. Did you create a timeline as part of Demonstrative No. 8?
5	A. I did.
6	MR. JONAS: Your Honor, if we can put on the second
7	page of Demonstrative No. 8.
8	Q. (BY MR. JONAS) What is happening now? This is how soon
9	after the last event?
10	A. Very soon after the actual the last wire went over to
11	the Islamic Relief Committee, but a week after or two weeks
12	after everything started in the last chart.
13	Q. Go ahead.
14	A. Okay. On August 10th, 1992, Hamas leader Mousa Abu
15	Marzook placed another call to the Defendant Mohamed El
16	Mezain. On that same day he issued another check for \$100,000
17	to the HLF. Two days later we located or there was a fax
18	dated August 12th, 1992 found in the Elbarasse materials.
19	Q. Let me stop you for a moment. Is Elbarasse Search No. 18
20	that fax?
21	A. It is.
22	Q. And does it relate to these transactions that you are
23	testifying about?
24	A. It does.
25	MR. JONAS: Your Honor, I am not sure if I offered

-	
1	Elbarasse Search No. 18 into evidence. I am doing so at this
2	time, if I have not already.
3	THE COURT: I don't show it in. Any objection to
4	that? It is admitted.
5	MR. JONAS: And why don't we pull up Elbarasse
6	Search No. 18 and look at it.
7	Q. (BY MR. JONAS) Okay. It is in Arabic. Is that correct,
8	Agent Burns?
9	A. That is correct.
10	Q. Did the FBI translate it?
11	A. Yes.
12	Q. What page is the English on?
13	A. Well, at first if you look on the original in the Arabic
14	it says from Islamic Relief Committee or Islamic REL Committee
15	with the date August 12, 1992.
16	Q. Is that the same committee that we looked at the last
17	financial summary chart of where payments began in the early
18	'90s, I believe, and ended up after Hamas is designated?
19	A. We looked at the chart from the HLF the to Islamic Relief
20	Committee. Correct.
21	Q. By the way, how much did HLF pay the Islamic Relief
22	Committee in total?
23	A. Over \$1.4 million.
24	Q. Okay. What is the first page of the English on this
25	document?

113
A. It is page 10.
Q. And what is it about this document that drew your
attention?
A. It was addressed to the brothers, and it was found at
Ismail Elbarasse's home, along with all these other documents
that we have been talking about. And it is a request it is
a letter, it is probably about eight pages long, the
translation is, anyway, addressed to the brothers, and it
reports on a visit of the individual who wrote the letter, to
Palestine in 1992 around the same time of the events that we
are discussing in these charts.
If go to page 13 of the exhibit, and in the middle there
where it says "Our belovedour brothers" the author is
saying Do you want me to read it?
Q. Yes, please.
A. "It is an appeal for help from your brothers to you, and
from hearts full of wounds, hearts that are not shaken by
tornados, and that are not moved by the wind to their brothers
in the leadership of Hamas: Do not forsake your
brothersyou fill the earth, and the Muslim Ikhwan are in
every part of it.
"And they tell you, 'Give us weapons and take men whom
the world will recognize,' God willing, even if the criminals
hate it and even if the Christians and those who stir up
sedition hate it.

1 "And if the hateful hate it. 2 "Weapons...to protect your brothers who are threatened by 3 the eagles of treason, weapons to carry out Jihad operations 4 and ask Khan Younis about the day of July 22nd." Is there anything else in that letter of note? 5 Q. 6 Α. Yes. On the following page, page 14, the author under 7 the third paragraph says, "Therefore, I appeal to you to take a quick action and find out the needs of the Inside so that 8 the families of our brothers do not suffer more frustrations 9 10 than what is already there. To my humble knowledge, the transfer channels are now open and without problems. 11 12 Examining the delivery channels, placing each channel in its 13 main purpose without using its funds for other channel means: No. 1 "The detainees and the needs of their families. 14 15 Their funds are to be in a specific channel and distributed 16 throughout The Strip. 17 "The martyrs. "Those afflicted among our brothers by the demolition of 18 19 their homes and severance of income. "The activities...and these are numerous and varying. 20 "The economic projects. 21 22 The Islamic University. 23 "The Islamic Complex. "The Islamic Society." 24 The Islamic Complex, is that an organization that we have 25 Q.

1	already talked about the HLF sending money to?
2	A. It is.
3	Q. Okay. Agent Burns, you say this came from the Islamic
4	By the fax title, it came from the Islamic Relief
5	Organization?
6	A. Yes. According to the fax title, that is where it came
7	from.
8	MR. JONAS: And if we can go back to the timeline.
9	Q. (BY MR. JONAS) Please continue explaining.
10	A. Six days after the date of that fax, the HLF approved
11	another \$100,000 wire transfer for the Islamic Relief
12	Committee. And the individuals that were indicated in that
13	committee, and we can go to it in a minute, most of them were
14	families of prisoners.
15	Q. Well, were you able to account for the \$100,000 in this
16	project, this \$100,000 wire?
17	A. No. This project was the same as the last. The initial
18	paperwork If we want to go to it, it is InfoCom Search No.
19	4, page 1. You will see there in the middle it indicates that
20	the \$100,000 went to 100 families in Gaza and the West Bank.
21	And all of the supporting documentation, the applications for
22	the families that needed support is attached, again,
23	approximately 100 families. And as I stated in that chart, a
24	majority of the families were family members of people who
25	were detained, and that documentation is contained herein.
l	

1	In this project as well as the other one, there was a
2	report on page 3 is the Arabic version, that in November of
3	1994 was filled out. And I am not sure what page the
4	translation is on. If it is not immediately after that we
5	will have to scroll through for the translation. But
6	basically it says the same thing as the previous one didthat
7	there were 500 families sponsored.
8	Q. Did you find supporting documentation for 500 families in
9	this project?
10	A. No, I did not.
11	Q. So again, if you are looking at 100 families at
12	approximately \$200 a family, \$20,000 is accounted for?
13	A. That is true.
14	Q. And this wire was for \$100,000?
15	A. That is correct.
16	MR. JONAS: If we can go back to the chart, please,
17	the timeline.
18	Q. (BY MR. JONAS) What happened after the \$100,000 was
19	approved by Ghassan Elashi to send to the Islamic Relief
20	Association?
21	A. The next day the money was actually sent, the \$100,000
22	was sent from the HLF to the Islamic Relief Committee.
23	Q. Thank you.
24	MR. JONAS: Your Honor, I know it is a few minutes
25	early, but I am at a real good breaking point.

1 THE COURT: Let's take a break. Be back at 1:45. 2 (Whereupon, the jury left the courtroom.) 3 THE COURT: Agent, you may step down. Ma'am, on the front row with that magazine, let me see 4 those documents you are holding up. I could read them from 5 6 here. Come up here a minute. 7 Everybody else can have a seat. 8 Mr. Jonas, do you want to take the documents there? Hand those to Mr. Jonas so I can see what it is you are 9 10 holding up. I could read something. MR. JONAS: Evolution. The back part is disputed 11 12 territories. 13 THE COURT: Flip to the front. The magazine is 14 open. I saw something. And then the other side. That is 15 That is what I read. what I saw. That is inappropriate for you to have that in here, 16 17 ma'am. And I heard that you were displaying it out in the hall earlier. That is totally inappropriate. We have jurors 18 19 that are coming in and out. I don't know whether you are 20 trying to influence jurors or not. 21 UNIDENTIFIED OBSERVER: I am just trying to be 22 informed about this. 23 THE COURT: You can be here, certainly, and be 24 informed, but it is not proper to try and influence. It is 25 improper to be showing it in here and be carrying it out there

1 where others can see that. 2 THE OBSERVER: I appreciate that. THE COURT: Make sure you don't do that. 3 That is 4 totally inappropriate. 5 THE OBSERVER: Thank you very much. 6 THE COURT: All right. We are in recess. 7 (Lunch Recess.) 8 MS. CADEDDU: Your Honor, may we approach? 9 THE COURT: Sure. Come on up. 10 (The following was had outside the presence and 11 hearing of the jury.) 12 THE COURT: Here we are again. 13 MS. CADEDDU: Here we are again. I am sorry. 14 Your Honor, I was unaware until today of the lady you 15 called out and what she was doing. But I wanted to put on the 16 record exactly what the article said and where she was sitting 17 and what she was doing. But before I do that, it has come to our attention that 18 19 people in the gallery have us that she was holding up another 20 article that said "Hamas rock star" during the Government's 21 playing my client's performances with the band during the 22 video being played for those. 23 She also today was --THE COURT: Last week? 24 25 MS. CADEDDU: That was Thursday, yes, sir.

1	And today during breaks she was showing that article to
2	various people in the hallway. And then during the lunch
3	break, I actually saw this myself, she was pulled aside by the
4	CSO who asked I think for identification, and then when that
5	interchange was done, she and her friend went and stood next
6	to two of the jurors who were waiting for an elevator and
7	proceeded to have a conversation and paged through the
8	documents. This was after you instructed her.
9	THE COURT: Just now at the lunch break?
10	MS. CADEDDU: Yes. And to put on the record, the
11	article that she was holding up for the Court said "Hate
12	speech is not free speech." And she was sitting directly
13	behind and I am not suggesting the Government had anything
14	to do with it, but that is where she was sitting.
15	THE COURT: In the middle of the courtroom.
16	MS. CADEDDU: Yes. So what we would like to do is
17	to make inquiry of her the next time she is here about whether
18	she has had any interchanges with jurors and whether she has
19	shown them any documents or had any discussions with them. I
20	mean, this is obviously of a very great concern.
21	THE COURT: All right.
22	MR. CLINE: Your Honor, if I may add, in addition to
23	making the inquiry, admonish her again not to have inside or
24	outside the courtroom, any contact with the jurors. She seems
25	like a person on a mission.

THE COURT: Do you know her?
MR. JONAS: No, sir. We have no idea who she is.
MS. HOLLANDER: If I may add a little bit, she is
also drawing pictures, and I don't think we can stop her from
this.
THE COURT: We might, depending on what she is
drawing.
MS. HOLLANDER: She is drawing counsel. She was
drawing one of the Defendants' and daughter.
MS. MORENO: Only if it is flattering to me.
Otherwise
MS. HOLLANDER: But I just want to make that part of
the record, that that is what she is doing, and she was
writing in Hebrew.
THE COURT: Okay. Just remind me next time she is
in, and we will find a good time to break and I will talk to
her about that, and I will talk to the CSOs and see what they
saw as far as with having any contact.
MR. JACKS: I might have missed, how do we know what
the articles were about or anything?
THE COURT: I don't know what they were about, but
what I saw it said "Hate speech is not free speech." Of
course, that is related to what is going on here, and we don't
need that.
MR. JACKS: I understand.
MR. JACKS: I understand.

1	THE COURT: She got up, as soon as they said, "All
2	rise for the jury," she stood up and I saw that right away.
3	So I know the jury could see if they were looking. The jury
4	is coming this way, so hopefully nobody saw it. But by the
5	time she came up to Barry, she had already flipped the page
6	and that is not what was showing, so it she indicated to me
7	she knew, she was hiding it. And I had already heard that
8	there was somebody showing something, but wasn't real
9	specific. But when I saw that I knew it was her, but then
10	when I saw that, that just caught my attention right away.
11	MS. CADEDDU: Just for the record, Your Honor, the
12	reason we know what the article said that she was showing to
13	people is because she actually showed it to Ms. Hollander's
14	paralegal. The article said, "Hamas' rock star," and was
15	showing her "Is this Mufid? Is this his picture? This is
16	Mufid Abdulqader And so she approached her without knowing who
17	she was or who she was associated with.
18	THE COURT: In the courtroom or in the hall?
19	MS. CADEDDU: I believe in the hallway on a break.
20	And of course our jurors are milling around with everyone
21	else.
22	MR. CLINE: Your Honor, two other quick things
23	before we break here. I talked with Mr. Jonas, and with the
24	Court's permission these 106 issues that keep coming up, if
25	you don't mind, we would prefer to raise those on cross.

1	THE COURT: Yeah. I don't mind. That is generally
2	the cleaner way to do it, rather than having to have this.
3	MR. CLINE: The Government will reserve its
4	objections under 106 to particular things we want to put in,
5	but it won't argue we are too late because we are doing it on
6	cross.
7	THE COURT: At that point I don't think it is even a
8	106. If it is relevant you are entitled to cross on something
9	that you think is relevant and get it in. 106 is a
10	contemporaneous issue, and then you have to read it and take a
11	look at everything. That is not a decision that I can always
12	make just real quick. It takes some time.
13	MR. CLINE: So we will do that on cross.
14	THE COURT: I think you will get a lot more latitude
15	on cross.
16	MS. HOLLANDER: But it can still be a 106 on cross?
17	THE COURT: If you want to call it that. I just
18	generally call it cross.
19	MR. WESTFALL: Just related writings and the rest of
20	the documents will come into evidence.
21	THE COURT: 106, I see this as a narrow rule. It is
22	something that should be considered contemporaneous, and that
23	is a narrow rule. I generally like to do it, prefer that you
24	do it on cross, and you can get into whatever you want to on
25	cross, if it is relevant.

1	MR. CLINE: The other thing isagain, I took this
2	up with Mr. Jonaswe had the discussion this morning about
3	giving the Government on cross exhibits, which we will do.
4	Mr. Jonas has agreed on behalf of the Government, and I agree
5	on behalf of all the Defense, that we will not show that list
б	to the witness who is on cross so that if there is an element
7	of surprise to be had, we will preserve it, but the Government
8	can prepare.
9	THE COURT: I think that is the way to handle it.
10	MS. MORENO: And also that may not be exhaustive,
11	depending upon what testimony the witness
12	THE COURT: I understand.
13	MR. CLINE: We will make a good faith effort to do
14	that.
15	THE COURT: You should know most of it, but if
16	something comes up we can all live with that.
17	(The following was had in the presence and hearing
18	of the jury.)
19	THE COURT: Mr. Jonas?
20	MR. JONAS: Thank you, sir.
21	Q. (BY MR. JONAS) Agent Burns, I want to get back and talk
22	about the Palestine Committee.
23	A. Okay.
24	Q. Did the Palestine Committee have any meetings that were
25	recorded by the FBI?

25	peac	e accords between the Palestinians and the Israelis.

1	Q. Okay. For purposes of your testimony, would it be fair
2	to call this the Philadelphia meeting or the Philly meeting?
3	A. Yes.
4	Q. Were there planning conversations on the
5	call Withdrawn. Did any of the Defendants or any of the
б	participants have any phone calls where they discussed the
7	planing of the Philadelphia meeting?
8	A. Yes.
9	Q. And were those phone calls intercepted by the FBI?
10	A. Some of them were, yes.
11	Q. Do you have what has been marked Ashqar Wiretap No. 1?

13	Q. And can you remind us who Ashqar is?
14	A. Ashqar is one of the members of the Palestinian Committee
15	that we saw on the list. Also his home is the one that was

24	into evidence Ashqar Wiretap No. 1 and 1-A.

12	Q. Who is that?
13	A. That is the Defendant Mohamed El Mezain.
14	Q. Do you know who Aboul Hasan is?
15	A. Aboul Hasan is the nickname for Abdel Haleem Ashqar, who
16	is also a participant in this call.
17	Q. Would that be AB, the next person speaking?
18	A. That is correct.
19	Q. Who is Abu Mohamed?
20	A. Shukri Abu Baker uses the name Abu Mohamed, but I believe
21	Omar Ahmad also uses that nickname.

20	Q. And what does that mean?

22	sessions based on topics, and individuals wrote papers
23	regarding certain topics, like media and charity work, and
24	presented those papers to the meeting attendees and they
25	discussed the papers.

21	reviewed, did you come across any written itinerary for the
22	Philadelphia meeting?
23	A. I did.
24	Q. Do you have before you Ashqar Search No. 4?
25	A. I do.

1	Q. Where did that document come from?
2	A. That came from the covert search of the home of Abdel
3	Haleem Ashqar.
4	Q. And Ashqar was a participant in that first call we just
5	played planning the meeting?
6	A. In both of the calls that we just discussed.
7	MR. JONAS: Your Honor, at this time I would offer
8	into evidence Ashqar Search No. 4.
9	THE COURT: That is admitted.
10	MR. JONAS: If we can put that on the screen,
11	please, starting with the first page. The next page.
12	Q. (BY MR. JONAS) Agent Burns, the first page it
13	said Withdrawn. What language is this document in?
14	A. Arabic.
15	MR. JONAS: And if we can go to page 4, please.
16	Q. (BY MR. JONAS) What is the title of this document?
17	A. "Future of Islamic Action for Palestine in North America
18	seminar, 2-3 October, 1993."
19	Q. The title "Islamic Action for Palestine," have we seen
20	that title used in any of the documents you testified about
21	already?
22	A. Yes. I believe it has been in several, most prominently
23	in the October 1992 internal memorandum from the international
24	Muslim Brotherhood.
25	Q. That was one of the Elbarasse documents you testified

2 A. That is correct.

3	Q. On this particular document, just summarize it for us so
4	we don't need to read the whole thing.
5	A. Basically it lists under No. 1 the goals of the seminar,
6	the Philadelphia meeting. No. 2, describes how the sessions
7	will be moderated and lists the names of like, for example,
8	session moderator under the first session, if you will scroll
9	down, is the Defendant Shukri Abu Baker. So it identifies the
10	topic of the first session, the people who will participate,
11	the individual who is moderating.
12	And the same thing for the second session, which is
13	charity work, and identifies who will present the papers, and
14	who will be moderating the session.
15	And on the next page it identifies the topic of the third
16	session, and who would be presenting papers, and the moderator
17	of the session.
18	Q. Thank you.
19	Agent Burns, did you create a summary chart identifying
20	who attended the session and the documents that you reviewed
21	that helped you identify those people?
22	A. Yes.
23	Q. What did you base your summary chart on?
24	A. We based the summary chart on a variety of different
25	exhibitsthe planning phone calls that we just listened to,

1	the actual meeting transcripts themselves, and in the
2	transcripts we were able to identify some of the speakers at
3	the conference.
4	There were also records from the search warrant
5	indicating like American Express bills indicating plane
6	tickets that were purchased for individuals. In addition,
7	there were records obtained from the Marriott Hotel at the
8	time the meeting took place.
9	Q. What Marriott?
10	A. I believe it was Courtyard by Marriott in Philadelphia.
11	MR. JONAS: Your Honor, may I approach?
12	THE COURT: Yes.
13	Q. (BY MR. JONAS) Agent Burns, I am holding up for you what
14	has been marked as Philly Meeting Summary. Is this the chart
15	that you prepared based upon the records you talked about of
16	who attended the Philadelphia meeting?
17	A. Yes, we prepared that.
18	Q. Would this aid the jury in your testimony this afternoon?
19	A. Yes.
20	MR. JONAS: Your Honor, at this time I would offer
21	into evidence Philly Meeting Summary.
22	THE COURT: That is admitted.
23	MR. DRATEL: I am going to object, Your Honor,
24	because it is misleading with respect to Mr. El Mezain. It
25	says the meeting. He wasn't at the meeting. The Government

14	version, the one that is the actual exhibit?

16	Q. Okay. Can you first walk us through this by explaining
17	across the top what the row is?
18	A. Well, the first column would be the attendees, the name
19	of the individual that we will be discussing.
20	The next column are the organizations that the individual
21	belonged to according to the evidence that we have discussed.
22	The next column is a column which references AMEX No. 1,
23	which is an exhibit that we will be discussing here. If that
24	individual appeared in those records as having attended the
25	Philadelphia meeting, there will be a checkmark by that

1 individual's name under that column.

2	The next column is Marriott Hotel records, which were the
3	records that were obtained from the Marriott Hotel at the time
4	of the conference. If the individual Defendant's name appears
5	in those records, a checkmark will appear across from his name
6	under that column.

7 The next column is listed "speaker at conference," and we 8 have 18 transcripts of conversations that took place during 9 the conference that were recorded. If the individual either 10 self-identified or his voice was identified by the language 11 specialist as speaking at the conference, there will be a 12 checkmark under his name on the chart.

13 Next, there were some surveillance photos that were taken by FBI agents back in 1993 of the meeting, and if individuals 14 15 could be positively identified in any of the surveillance 16 photos, there is a check under that column by their name. 17 And then finally, the last column is for planning phone calls, and if the individuals were mentioned as being invited 18 19 to attend the conference in those calls, there will be a 20 checkmark by that individual's name under that column. 21

21 MR. JONAS: Your Honor, at this time I would like to 22 offer into evidence the supporting documentation for this 23 chart, to the extent some of it is not already admitted. We 24 have AMEX No. 1.

25 Q. (BY MR. JONAS) And Agent Burns, whose records are AMEX

1	No. 1?
2	A. AMEX No. 1 are records obtained from the I am looking
3	to make sure I am right, because we had American Express
4	records from two different places. From American Express.
5	Q. Whose American Express records are they?
6	A. The Holy Land Foundation.
7	Q. Okay.
8	MR. JONAS: Your Honor, we also offer to admit
9	Marriott.
10	Q. (BY MR. JONAS) What is Marriott? What exhibit is that?
11	A. Marriott is the name of the exhibit for the Marriott
12	Hotel records.
13	MR. JONAS: We offer to admit Philly Meeting No. 1
14	through 18.
15	Q. (BY MR. JONAS) And what is that?
16	A. Those are the English transcriptions of the conversations
17	at the meeting.
18	MR. JONAS: Your Honor, I will have to explain in a
19	moment what we did with those.
20	Q. (BY MR. JONAS) And finally Philly Pictures 1 through 6?
21	A. Those were some of the surveillance photos that agents
22	took back then.
23	Q. Okay.
24	MR. JONAS: Your Honor, with Philly Meeting No. 1
25	through 18, which are the transcripts of this meeting that

L

1 took place, we are offering it a little bit differently than 2 the intercepted calls. We are offering the whole conference 3 into evidence. And I will have Agent Burns explain in a 4 moment why it is divided into 18. So the audio disk, which would be Philly Meeting No. 1-A is a disk of that whole tape 5 6 for that section. 7 But in addition, we are offering an excerpted transcript. So we have the full transcript and then an excerpted 8 transcript, and that is Philly Meeting E. So if we have for 9 10 example, No. 1 would be the full transcript, 1-A is the audio, and 1-E is the excerpt of that particular session of Philly. 11 12 THE COURT: You are offering No. 1, 1-A and 1-E. 13 Yes, sir, through No. 18, 18-A, and MR. JONAS: 18-E. 14 15 I just have a question. MS. HOLLANDER: We don't 16 have any objection to these, but is that the entire Philly 17 meeting? 18 MR. JONAS: No. 1 through 18 is the entire Philly 19 meeting. 20 MS. HOLLANDER: Okay. We don't object, as long as 21 it is the entire meeting. 22 MR. JONAS: That is my understanding. 23 THE COURT: And the AMEX records is AMEX No. 1? 24 MR. JONAS: Yes, sir. 25 MS. HOLLANDER: We don't object to the others.

1	THE COURT: All right. Those are admitted, then.
2	Q. (BY MR. JONAS) Agent Burns, first of all, why is there
3	18 tapes or transcripts of the Philadelphia meeting?
4	A. As I understand it, back in 1993 the equipment that the
5	FBI used to record these conversations, it was some type of
6	tape. I don't know if it was a cassette tape, or I believe it
7	may have actually been one of those old reel to reels. But
8	they were limited in length, so that once one was filled up
9	they would have to remove it and replace it with a new tape.
10	So we have a transcript for each tape that was made. So there
11	were approximately 18 tape recordings of that meeting.
12	Q. And did the FBI record this meeting pursuant to a court
13	order?
14	A. They did.
15	Q. Was this part of the intelligence investigations of
16	certain individuals?
17	A. It was the intelligence investigation of Ashqar.
18	Q. Agent Burns, there is a blank line about six names, seven
19	names up from the bottom between the name Abu Ahmad and
20	Mohamed El Mezain. Can you explain why that is?
21	A. Yes. Originally when preparing this chart there were
22	individuals who were invited to attend the conference based on
23	the planning calls, but that we affirmed did not attend for
24	one reason or another. Those individuals were to be listed
25	below that line as having been invited but not having

1 attended. 2 However, there is I believe an error in that the second 3 individual listed, Mohamed Al Hanooti, should appear above the 4 blank line, as there is other evidence that he did in fact 5 attend. Is that other evidence contained within the evidence 6 0. 7 admitted? 8 Yes, it is. Α. Agent Burns, I just want to pull up some of these 9 Q. 10 documents? 11 MR. JONAS: If we can pull up AMEX 1, page 6, 12 please. 13 Your Honor, I assume, just for the record, they are all admitted, the documents I offered into evidence? 14 15 THE COURT: Yes. 16 MR. JONAS: Thank you, sir. 17 Ο. (BY MR. JONAS) Agent Burns, do you see any individuals who went to the Philadelphia conference on this page with 18 19 particular charges? 20 I am going to look at my hard copy because it is a Α. Yes. little bit difficult to read on my screen. 21 22 Ο. We will zoom in as soon as you tell me which one to zoom 23 in on. Third from the top on the left side there, item 24 Α. Okay. No. 27 I believe it is called. 25

Q. Who is being paid for here?
A. Okay. On this Again, this is an American Express
bill. It lists the transaction date, which would be the date
of purchase. It does not list the date of travel. So this
shows that on September 3rd, 1993, a ticket was purchased for
Haitham Maghawri from Dallas to Philadelphia. We do not know
the exact travel date for that ticket.
MR. JONAS: Page 11, please.
Q. (BY MR. JONAS) Who is traveling now to Philadelphia?
A. At the bottom, the two entries there show that on
September 10th, 1993, airline tickets were purchased for
Shukri Abu Baker the Defendant, and also the Defendant Ghassan
Elashi, from Dallas to Philadelphia.
MR. JONAS: Page 12, please.
THE WITNESS: I guess the entire middle section you
can highlight.
This shows that on September 16th up in the upper left
corner, September 16, 1993, that the Holy Land Foundation
purchased an airline ticket for G. Saleh, who is Ghassan
Saleh, from Dallas to Philadelphia.
Moving across the page, on September 17th, 1993, the Holy
Land Foundation purchased an airline ticket for O. Amhad to
Philadelphia, which would be Omar Ahmad.
Q. If I can interrupt you for a moment. Where have we seen

1	A. Well, he was listed with the IAP, but also with the
2	Palestine Committee, on the Elbarasse list of Palestinian
3	Committee members and the Ashqar list of Palestinian Committee
4	members.
5	Q. And was he involved in that planning phone call that we
6	played for this meeting?
7	A. Yes, he was.
8	Q. You testified that these are the HLF AMEX records?
9	A. Yes.
10	Q. Was Omar Ahmad an employee of the HLF?
11	A. No, he was not.
12	Q. Was he a board member?
13	A. No.
14	Q. Was he an officer?
15	A. No.
16	Q. Based upon the material that you reviewed, did he have
17	any role with the HLF?
18	A. Only in respect to his role in the Palestinian Committee.
19	Q. Okay. Thank you.
20	MR. JONAS: If we can turn to page 14, please.
21	Q. (BY MR. JONAS) Whose tickets are the HLF paying for
22	here?
23	A. This is Sharif Battikhi, the second from the top on the
24	left column.
25	Q. We saw his name in a document the other day, didn't we?

1	A. We did.	
2	Q. Who is he?	
3	A. In 1991, he was appointed as a member of the HLF's board	
4	of directors.	
5	Q. Okay.	
6	MR. JONAS: If we can turn to page 12, back to page	
7	12.	
8	Q. (BY MR. JONAS) Do you see any hotel bills here?	
9	A. Yes. In the bottom on the it shows that the HLF paid the	
10	Courtyard by Marriott in Philadelphia \$116.41. And you can	
11	see the arrival and departure dates, so presumably this would	
12	be one room, october 1st through October 3rd.	
13	MR. JONAS: Page 13, please.	
14	Q. (BY MR. JONAS) Are they paying for more hotel rooms?	
15	A. Yes. This entire page is filled with charges to the Holy	
16	Land Foundation's American Express bill for rooms at the	
17	Courtyard by Marriott in Philadelphia for that time period.	
18	MR. JONAS: If we can go back to page 1 on this	
19	exhibit. Enlarge the top half, please.	
20	Q. (BY MR. JONAS) Do we see I just want to confirm it	
21	says whose credit card this is?	
22	A. The Holy Land Foundation, specifically Shukri Abu Baker's	
23	card.	
24	Q. And do you see any other individual's names who have	
25	access to this card?	
1	A. It says card member names down below, Shukri Abu Baker,	
----	---	
2	the Defendant Mohamed El Mezain, and Haitham Maghawri.	
3	Q. Okay. Agent Burns, let's look at the Philly Pictures.	
4	If we can put up on the screen Philly Picture 1. You	
5	testified these are surveillance photos?	
6	A. They are.	
7	Q. Do you recognize this individual?	
8	A. This person was identified as Ismail Elbarasse.	
9	Q. And who is he again?	
10	A. One of the IAP members; again, one of the Palestinian	
11	Committee members, whose home was search where we obtained	
12	most of these documents in Arabic that we have been	
13	discussing.	
14	Q. Okay.	
15	MR. JONAS: Philly Picture No. 2, please.	
16	Q. (BY MR. JONAS) Do you recognize this individual?	
17	A. Yes. This is a side view of the Defendant Ghassan Elashi	
18	in front of the hotel.	
19	MR. JONAS: Philly Picture No. 3, please.	
20	THE WITNESS: This is a picture of the Defendant	
21	Shukri Abu Baker and Ghassan Elashi.	
22	MR. JONAS: Philly Picture No. 4, please.	
23	THE WITNESS: Again, the Defendants Shukri Abu Baker	
24	and Ghassan Elashi.

23	A. Ghassan Saleh.
24	Q. Who is that?
25	A. This individual is Muin Shabib.

1	Q. Did you hear him on the tape speaking in Philadelphia?
2	A. They spoke about him in the call, in the planning call,
3	and that he would be an attendee.
4	Q. And was he actually there?
5	A. Yes, he was.
6	Q. What does this one indicate?
7	A. This, and a few of the following pages, are of the little
8	signature cards that you sign at the hotel when you check in.
9	This one is in the name, and you can see the original name it
10	was in was Hasan Sabri, and then /Maghawri was written in, and
11	it was signed at the bottom by Haitham Maghawri, the HLF
12	officer.
13	Q. Okay.
14	MR. JONAS: Next.
15	Q. (BY MR. JONAS) What is happening here?
16	A. Again, this one says has the name Hasan Sabri with a line
17	through it and then has Ghassan Saleh and Riad Ahmed written
18	beside it. And I can't tell by whom it is signed.
19	Q. Okay.
20	MR. JONAS: Next.
21	Q. (BY MR. JONAS) Which one is this?
22	A. This one is for room 227 under the name of M. Abdulqader
23	of Richardson, Texas.
24	Q. Who is that?
25	A. That would be the Defendant Mufid Abdulqader.

1	Q. It says void across it. Does that mean he wasn't there?
2	A. He had to have been there because he signed the card, and
3	that is his actual signature at the bottom. I don't know if
4	the room was canceled I don't know why the word void was on
5	there, but he had to have at least been present at the hotel

7	Q. What does it say in the top right hand side of this
8	document?
9	A. It says "Believe to move to 307 or 301."
10	MR. JONAS: Let me jump to page 13 the Marriott
11	records.
12	Q. (BY MR. JONAS) What is this one?
13	A. This one is the signature hard for room 401 originally in
14	Hasan Sabri's name, then Mohamed El Mezain's name is noted,

16	Q. Okay. Thank you. Did Mohamed El Mezain attend?
17	A. No, he did not.
18	Q. Was that discussed in the Philadelphia meeting?

25	Q. (BY MR. JONAS) Did you see where it says, "Abou Ibrahim

1	should have been with us but he is at the hospital for those
2	that don't know"?
3	A. Yes.
4	Q. Is that your explanation for why Mohamed El Mezain wasn't
5	there, to your understanding?
6	A. Yes.
7	Q. In Shukri Baker's declaration did he say this is a
8	meeting of the Palestine Committee?
9	A. No, he doesn't.
10	Q. Do you see where it says "union"?
11	A. I do.
12	Q. Is that correct?

16	is speaking, all one has to do is go to the first page of the
17	transcript and they can see who that person is. Is that
18	correct?
19	A. That is correct. And with each transcript, different
20	speakers will probably be identified. So on one transcript
21	you may have five or six people, and on another transcript you
22	may have ten people.
23	Q. And did Shukri Baker in fact moderate any sessions?
24	A. He did.
25	Q. Okay. Agent Burns, did Shukri Baker the Defendant talk

1	about presenting a cover for this Philadelphia meeting in case
2	anyone asks?
3	A. He did.
4	MR. JONAS: If we can turn to Philly Meeting No. 3.
5	Q. (BY MR. JONAS) Before I ask you about that one, did they
6	jump around in subject matter during their sessions?
7	A. Yes. As you can see, the conference was organized into
8	sessions according to topic, but they did venture off of topic
9	on several occasions, and then they would try to get back on
10	topic. But they do venture around.
11	Q. Okay. So we may venture around ourselves, then?
12	A. Yes, we will be doing that.
13	Q. Okay.
14	MR. JONAS: If we can turn to Philly Meeting No. 3,
15	page 3. This is the excerpted one, Philly Meeting No. 3-E.
16	THE WITNESS: I have it.
17	Q. (BY MR. JONAS) Do can you have it before you?
18	A. I do.
19	Q. This is a short one so we will just read it. Do you see
20	the second from the top segment? Can you read what Shukri
21	Baker says about the meeting?
22	A. "My brothers, this talk is to be continued, God's
23	willing. There are remarks now. Please don't mention the

25	sister Samah. We will talk about her honor, and the session

1	is the session here is a joint workshop between the Holy

4	Q. Agent Burns, going back to your Philly Meeting Summary
5	Chart, under organizations you list several organizationsPC,
б	HLF, IAP, depending upon the individual. Can you explain

8	A. Yes. Individuals who are affiliated with various
9	organizations, according to the evidence that has already been
10	presented, their affiliations are noted in that column. For
11	example, with the Defendant Shukri Abu Baker we have seen
12	documents that we have are introduced here showing that he was
13	a member of the Palestinian Committee and the HLF, and we have
14	seen his deposition testimony where he admitted being a member
15	of the IAP's advisory board. Therefore, all three
16	organizations are noted beside his name.
17	Q. Okay. And that continues throughout this chart?
18	A. That is correct.

20	Q. (BY MR. JONAS) Agent Burns, do you see where Shukri
21	Baker says, "visited their aunt's house"?
22	A. I do.
23	Q. Have you seen that term used before?
24	A. I have.
25	Q. Where?

1	A. I have seen it in some of the evidence here; none that we
2	have discussed yet.
3	Q. Without giving your understanding of it, is it a word
4	that In the context that you have seen it, not just in this
5	call, but other contexts, is that a code word?
6	A. It is a code word.
7	Q. Okay. Agent Burns, do you see where it says, "he claims
8	a relation to her, this Hajja Samah"?
9	A. I do.
10	Q. Using the definition as applied in Baker's declaration,
11	the sworn statement, would that mean Hajja forgiveness?
12	A. If you look at his statement, but it makes no sense in
13	this context.
14	Q. Have you seen the term Hajja before?
15	A. Yes.
16	Q. Do you know what that means?
17	A. It can be translated as sister. It is more of a
18	respected female, but it can be translated as sister.
19	MS. CADEDDU: I object to her opining about what
20	things mean in Arabic. She is not an expert or translator.
21	She doesn't speak Arabic.
22	THE COURT: Overrule that objection. She may
23	testify to her understanding. Go ahead.
24	Q. (BY MR. JONAS) And is sister Samah the term that we have
25	seen used in the Philadelphia meeting?

1	A. It is.
2	Q. Agent Burns, do you see the term "old man"?
3	A. I do.
4	Q. Have you seen that term used before?
5	A. I have seen that term used in the context of this issue
6	and this evidence to mean Yasser Arafat.
7	Q. Agent Burns, have you seen the use of the term Samah in
8	other calls?
9	A. Yes.
10	Q. We will save them for later.
11	A. Okay.
12	Q. All right. You testified that at the time of the
13	Philadelphia meeting the Oslo Accords had just come out.
14	Correct?
15	A. That is correct.
16	Q. Per the Hamas charter, what was Hamas' position on the
17	Oslo Accords?
18	A. Well, according to the Hamas charter they were opposed to
19	any type of peaceful compromise with the Israelis. The
20	charter predated the Oslo Accords, the signing of the Oslo
21	Accords.
22	Q. Did the participants in the Philadelphia meeting discuss
23	moving in the same direction as Hamas on this issue?
24	A. They did.
25	MR. JONAS: If we can play Philly Meeting No. 2-E,

1 Segment A, please. 2 (Whereupon, Philly Meeting No. 2-E, Segment A was played, while questions were propounded.) 3 4 (BY MR. JONAS) Agent Burns, what is the Fund? Q. That is the Holy Land Foundation. 5 Α. 6 Q. Agent Burns, do you see where it says, "The programs or 7 the organizations overall should be in complete harmony with 8 the general directions of the Movement"? What is the Movement? 9 10 The Islamic Resistance Movement, Hamas. Α. Who is Abou Ibrahim? 11 0. 12 Α. The Defendant Mohamed El Mezain. 13 Agent Burns, the individual I believe was Gawad who was Q. 14 speaking, talked about moving in directions. They talked 15 about the Movement being Hamas. Did Defendant Shukri Baker also talk about moving in particular directions? 16 17 Α. He did. If you will turn to Philly 18 MR. JONAS: Okay. 19 Meeting No. 6-E. 19	A. Yes.
20	Q. Used it a few times. Is that correct?
21	A. That is correct.
22	Q. Did any of the other participants discuss derailment?
23	A. Yes.
24	MR. JONAS: If we can turn to Philly Meeting No.
25	10-E, Segment D.

1 One moment, Your Honor. 2 THE COURT: Yes. 3 MR. JONAS: Your Honor, we are about to play about 4 four segments in a row, if you are ready to take a break. THE COURT: This is a good time to break? 8	A. I will confirm from the front page. That is Abdel Haleem

13	Q. (BY MR. JONAS) Agent Burns, who is speaking here?
14	A. This is Shukri Abu Baker.
15	Q. Okay. Agent Burns, did the participants in the
16	Philadelphia meeting ever discuss what they can and cannot
17	officially say in regard to their positions?

15	Q. (BY MR. JONAS) Agent Burns, you see where Shukri Baker
16	Is he the one speaking?
17	A. He is.

20	societies will be shut down." During the course of your
21	testimony have we talked about any societies that belong to
22	Hamas?
23	A. The Islamic Center of Gaza would be one.
24	Q. That was the one that was founded by Sheikh Yassin?
25	A. That is correct. That the HLF gave money to in the early

1	years.
2	Q. Agent Burns, do you see where Shukri Baker uses the word
3	Samah again?
4	A. I do.
5	Q. And under his definition would that say, then, "America
6	will classify forgiveness as a terrorist organization," if you
7	used the definition he provided in his declaration?
8	A. If you use the definition he provided in his sworn
9	declaration, in this context it makes no sense.
10	Q. Agent Burns, are you familiar with the al-Aqsa
11	educational that is in quotes there?
12	A. I am.
13	Q. Is that an entity we are going to talk about in a little
14	while?
15	A. That is an entity that we actually spoke about on
16	Thursday, Abdel Haleem Ashqar's educational fund.
17	Q. Ashqar is again who?
18	A. A member of the Palestine Committee.
19	Q. He was a participant in the Philadelphia meeting?
20	A. That is correct.
21	MR. JONAS: If we can play from Philly Meeting No.
22	5, Section J.
23	(Whereupon, Philly Meeting No. 5, Section J was
24	played, while questions were propounded.)
25	Q. (BY MR. JONAS) Agent Burns, at the time of the

1	Philadelphia meeting in 1993, had Hamas been officially
2	designated as a terrorist organization by the United States?
3	A. No. Actually the mechanism for designating an
4	organization as a terrorist did not exist at the time of this
5	conference.
6	Q. Are you aware if the United States in any way recognized
7	Hamas as a terrorist organization at around this time?
8	A. After the Oslo Accords, the U.S. State Department came
9	out and named them as a terrorist organization, but it did not
10	have the same effect as what an official designation would

24	Q. (BY MR. JONAS) Agent Burns, starting with the top where
25	it says UM, "I can repeat the text," can you read the rest of

1 this segment please?

2	A. "I can repeat the text if that is going to solve the
3	problem. We can say attacking the the credibility of the
4	representation of the Organization, the Organization's right
5	to sign an accord on behalf of the Palestinian people."
6	Q. Let me pause you for a moment. Which organization signed
7	the Oslo Accords on behalf of the Palestinian people?
8	A. The Palestine Liberation Organization.
9	Q. Okay. Continue.
10	A. Gawad says, "No, he didn't sign as the Organization. He
11	signed as Abu Ammar. He didn't sign as the Organization."
12	Unknown male says, "No, he signed the Palestinian people.
13	What's his name? Abu Abbas signed as the Palestinian
14	delegation."
15	Gawad said, "But not even one major democratic

16	mean, in the same style as Samah's"?

21	A. Shukri Abu Baker is.
22	Q. And Omar Yehia is who?
23	A. That is the same as Omar Ahmad the IAP member/Palestinian
24	Committee member who has been speaking quite frequently

1	Q. Shukri Baker says, "You can go meet a Congressman in your
2	name, in Omar Yehia's name, in the name of the Association's
3	present, and tell him [UI] doesn't represent us. Mr. Ahmad
4	Yassin represents us." Who is Ahmed Yassin?
5	A. The Hamas founder, the former spiritual leader that is on
б	your board there in the middle on the top.
7	Q. The top, Sheikh Ahmed Yassin?
8	A. That is correct.
9	MR. JONAS: If we can stay with Philly Meeting No.
10	8, page 5 of the Philly meeting 8-E, the excerpted portion,
11	the top half, please.
12	Q. (BY MR. JONAS) Agent Burns, if you can read what Shukri
13	Baker says at this point in the meeting?
14	A. He says, "The point you presented which is which is
15	withdrawing, attacking his credibility as a representative and
16	a leader of the Palestinian people. But I tell you that we
17	don't want the American front to become a front for direct
18	conflict. These things will put us in direct conflict, not
19	only with the Palestinians, even with the official government
20	circles. What is our benefit? What is our interest? As
21	Palestinian action organizations in America, what is our

5	Q. Okay. Agent Burns, have we already heard in some of the

7	discussion for a new organization?

9	Q. Has that discussion did that happen several times
10	where they discussed creating a new organization?
11	A. It did.
12	Q. Okay.
13	MR. JONAS: If we can turn to Philly Meeting No. 5,
14	and the excerpt if we can get page 1 on the screen, please.
15	Q. (BY MR. JONAS) Agent Burns, I will give your voice a
16	break and I will just read this one.
17	Unknown male 2 says, "In my opinion, we must form a new
18	organization for activism which will be neutral because we are
19	placed in a corner. We are placed in a corner. It is known
20	who we are. We are marked. And I believe that there should
21	be a new neutral organization which works on both sides so
22	that because this state is coming no matter what, and this
23	is a new existing order."
24	Agent Burns, were there any other discussions about them
25	being marked?

JONAS: If we can turn to Philly Meeting No. 13 in the excerpt, and if we can play segments F and G, please. 3 (Whereupon, Philly Meeting No. 13-E, Segment F and G 4 were played, while questions were propounded.) 5 6 Ο. 3	MS. MORENO: If I can get my notes, Your Honor?

19	organizations: IAP, HLF, UASR, Coordination, CAIR."
20	Q. Do you know what CAIR stands for?
21	A. Yes.
22	Q. What does it stand for?
23	A. Council on American-Islamic Relations.
24	Q. Prior to the Philadelphia meeting did you see the
25	organization CAIR mentioned in any of the Elbarasse documents?

1	A. It did not exist prior to the Philadelphia meeting.
2	Q. So it came into being after Philadelphia?
3	A. That is correct.
4	Q. Okay. Were there any additional discussions by the
5	participants about how they would portray themselves to
б	America?
7	A. Yes.
8	MR. JONAS: If we turn to Philly Meeting No. 16 and
9	the excerpts, if we can play Segment F and G together, please.
10	(Whereupon, Philly Meeting NO. 16-E, Segment F and G
11	were played, while questions were propounded.)
12	Q. (BY MR. JONAS) Who is speaking here?
13	A. This is the Defendant Shukri Abu Baker.
14	Q. Agent Burns, did you see in that segment where the
15	Defendant Shukri Baker talked about making presentations on
16	human suffering and the rights, the issues he understands, he

18	A. Yes.
19	Q. Were there additional discussions making presentations to
20	America on human rights?

25	Q. (BY MR. JONAS) What does this unidentified male say,
