COUNT 1: MURDER IN THE FIRST DEGREE - MALICE AFORETHOUGHT ~ a FELONY, on or about the 25th day of September, 2014, in Cleveland County, Oklahoma by unlawfully, willfully, and feloniously, without authority of law, with malice aforethought effect the death of one COLLEEN HUFFORD, a human being, by stabbing her with a knife, causing the death of COLLEEN HUFFORD, contrary to the form of the Statutes in such cases made and provided and against the peace and dignity of the State of Oklahoma.

COUNT 2: ASSAULT AND BATTERY WITH DEADLY WEAPON ~ a FELONY, on or about the 25th day of September, 2014, without justifiable or excusable cause commit an assault and battery on one TRACI JOHNSON with a deadly weapon, to-wit: a knife, by stabbing TRACI JOHNSON with a knife, contrary to the form of the Statutes in such cases made and provided and against the peace and dignity of the State of Oklahoma.
