

A Cooperation Agreement Between

The Arab Front for the Advocacy of Iraq and Palestine Represented by its President Professor Shaaban Hafiz The Government of Iraq Represented by the Foreign Minister or his representative

Due to the emergency conditions experienced by Iraq [The persevering and struggling], and its need to starve off the conspiracies and hostile schemes against the country and its people, and in order to protect its institutions and facilities, centers, government buildings, historical sites, strategic and security locations, and for self defense as a legitimate right entrusted by all religious and international laws, today / /2002 in Baghdad, the capital of the Republic of Iraq, a joint cooperation agreement was signed between the Republic of Iraq, represented by the Foreign Minister, Mr. Naji Sabri, or his representative, hereafter referred to as the first party, and the Arab Front for the Advocacy of Iraq and Palestine, represented by its president Mr. Shaaban Hafiz Shaaban, hereafter referred to as the second party. The agreement includes the following: 1. The second party shall organize and register American and foreign volunteers wishing to travel, and reside temporary in Iraq, for the purpose of protecting the sites and centers specified by the first party.

2. The second party shall clarify and acquaint the volunteers with their duties and missions, and specify the duration of their stay in Iraq, as well as their locations and the danger they would face in case the United States wages a war on Iraq. Also, the second party shall explain the responsibilities of the Iraqi government toward those volunteers, and the free services provided to them throughout their stay in Iraq.

The first party shall organize between 500 and 2000 volunteers according to the period specified by the first party. The majority of them shall be elderly, women, and children.
The first party shall bear all travel expenses, living accommodations, food, medicine, clothes, recreation, "spending money", and life insurance for all volunteers, in addition to a travel ticket given to every volunteer to visit his/her family when exceeding six consecutive months in Iraq.
As agreed, the first party shall transfer to the account of the second party a sum of money deemed adequate and sufficient. The second party promises to provide the first party a monthly

statement of all financial expenditures, as well as the remaining balance. The financial statement shall be prepared by an accountant agreed upon by both parties. No cash expenditures shall occur without the permission of the first party

6. The second party shall prepare a personal file for every volunteer. The file includes personal information such as name, address, profession, and the address of a close relative in case of an emergency while volunteering in Iraq.

7. The first party shall secure for the volunteers all safety equipment such as gas masks, chemical masks, fire deterrent suits, helmets, bullet proof vests, and enough food and water to



last for two months to be placed near their centers and locations, so that they remain protected and forming a human shield in order to protect it.

8. The first party shall endeavor faithfully to scrutinize the identities, and intentions of the volunteering, however, it is the responsibility of the first party to monitor and scrutinize the activities of the volunteers during their stay in Iraq, in order to ensure that no hostile individuals are among them.

9. The second party shall explain to the volunteers the Arabic and Islamic traditions, and shall stress the importance of respecting them while in Iraq, and avoiding any activity that might incite or anger the Iraqi citizens, or encroach on general moral, religious, and nationalistic values of various Iraqi sects.

10. The first party shall provide forcign volunteers with moral, monetary, and business incentives, as well as permanent residency to everyone who wishes [to do so] in the future, and award the active and competent ones with medals following the victory of Iraq, God willing, over the aggressors and conquerors.

11. This agreement is considered effective upon signing...
