The United States Attorney charges that:

From at least as early as in or about December, 2004 and continuing through in or about September, 2006, in Miami-Dade County, in the Southern District of Florida and elsewhere, the defendant, **RICHARD DAVID HUPPER**, a national of the United States, did knowingly attempt to provide material support and resources, as those terms are defined in Title 18, United States Code Section 2339A(b), that is: currency and monetary instruments to a foreign terrorist organization, that is, Hamas, which had previously been designated by the United States as a foreign terrorist organization under Title 8, United States Code, Section 1189(a)(1), in violation of Title 18, United

States Code, Section 2339 B(a)(1).
