The Plaintiffs respectfully submit the attached certified copy of the Warranty Deed. This document evidences that the Defendant Islamic Republic of Iran (aka Government of Iran) owns the real property that is the subject of the proposed execution. *See also, Hegna v. Islamic Republic of* Iran, 376 F.3d 485 (5th Cir. 2004).

The Defendant, which is currently known as "The Islamic Republic of Iran," has at

various times also used the names Iran, The Republic of Iran, Republic of Iran, The Government

of Iran, Iranian Government, and Imperial Government of Iran. This fact is expressly reflected in the caption of plaintiffs' judgment, which was entered against defendant Iran under all its alternative names.

Indeed, other recent federal court decisions against Iran also reflect these various names. See Stern v. Islamic Republic of Iran, 271 F.Supp.2d 286, 291 (D.D.C. 2003) (The Islamic Republic of Iran is "also known as 'The Republic of Iran', 'Republic of Iran', 'The Government of Iran', 'Iranian Government', 'Imperial Government of Iran', and 'Iran'").

Moreover, the Islamic government which currently rules Iran has been in power since February 1979, several weeks before the Warranty Deed was executed on April 18, 1979. *See e.g. Continental Illinois Corp. v. C. I. R.*, 94 T.C. 165, 167 (U.S.Tax Ct. 1990)("Khomeini set up a provisional Islamic government on February 11, 1979 ... The Islamic Republic of Iran was proclaimed on April 1, 1979."); *Boland v. Bank Sepah-Iran*, 614 F.Supp. 1166, 1168 (D.C.N.Y. 1985)("Ayatollah Khomeini and the Revolutionary Party took power in Iran in February 1979"); *Reading & Bates Corp. v. United States*, 40 Fed.Cl. 737, 744 (Fed.Cl. 1998)("On April 1, 1979, Khomeini declared the Islamic Republic of Iran").

Therefore, Plaintiffs respectfully submit that the property was transferred into the name of the Government of Iran, after the assumption of power by the current Islamic government.
